

Current spaces need repairs and expansion.



- Diverse project funding.
- Building ownership for maintenance that involves building systems
- Provides a public benefit.

Parameters

- · Reimbursable.
- Funding capped at 40% for large projects.
- Land costs must be tied to a facility project.

NOT FOR: operations or fundraising.
