Staff will give an update on the Innovation Forum work. The Innovation Forum is designed to advise city staff on advancing Bellevue's capacity as a city where innovation supports opportunity, equity, mobility, and economic development.

**BACKGROUND/ANALYSIS**

The Bellevue City Council Vision includes, *"Innovation is an integral part of our community. We embrace and support innovation in all aspects of our community – systems, institutions, businesses, schools and government. This innovative spirit is crucial to Bellevue's success."*

The goal of the Innovation Forum is to advise city staff on advancing Bellevue's capacity as a city where innovation supports opportunity, equity, mobility, and economic development. This topic was last before council on June 3, 2025.

**Background**

Staff started conversations with Council, community, and businesses in 2024 to solicit early input on how the City could further support innovation, both in delivery of city services, and in support of the innovative spirit of the community and businesses who call Bellevue home. Staff and volunteers completed 1 x 1 interviews with people representing residents, education, small business, digital equity, affordable housing, non-profit, and large businesses. Staff also conducted surveys and hosted events in City Hall for community input on priorities and work programs.

**Progress To Date**

The work program goals were established and endorsed at a forum event in mid-2025. Staff, businesses, non-profits, and community members have been working together to advance the short- and long-term goals that were identified. The table below reflects progress toward the established goals.

Community volunteers are interested in helping at key locations. Staff are working with Mini City Hall and King County Libraries to identify areas for augmentation.	In progress

Goal 2: Increase Participation	Participation went from 60 attendees at the first event to 273 at the Innovation Exchange in October. Work continues to expand partnerships and participation.	Complete/ongoing
Goal 3: Create a self-sustaining innovation hub	Work is in progress to identify, fund, and develop space at Bellevue College for startups, collaboration, training and testing civic innovation.	Ongoing

Bellevue ITD also hosted three innovation events in 2025, culminating in the Innovation Exchange on October 16, a full day of learning and partnership inside Bellevue City Hall. The Innovation Exchange had 273 attendees, 48 speakers and panelists, and 13 sessions including:

- Lightning talks on AI-powered permitting, digital twins and smart civic infrastructure
- Interactive tracks on civic transformation, AI productivity and workforce innovation
- Engaging workshops on AI ethics, small business tools and creative coding
- A vibrant evening plaza experience with music, food and community and non-profit showcases

Work is also underway with the inaugural four Civic Challenge partners. Most participants are currently working toward their second major milestones with city and college partners. The inaugural participants are scheduled to complete their pilots at the end of February.

- Certivo is partnering with ITD's cybersecurity team and FAM's procurement team to pilot an AI-enhanced dashboard for vendor compliance.
- Juganu is partnering with Bellevue's Transportation Team and Bellevue College to pilot smart streetlight monitoring for lighting, curb management, and traffic safety.
- Legislaide is partnering with the City Attorney's Office to pilot the use of AI-supported ordinance look-up, policy validation, and look-up history.
- FindIT AI is partnering with Bellevue College on an AI-enabled lost and found tool. This special youth partnership was awarded to a high school student.

### **Upcoming 2026 Innovation Work**

The innovation team will continue to advance the long- and short-term workplan established in mid-2025. Specific areas of focus in 2026 include the following:

1. The City of Bellevue and Bellevue College are partnering to build a non-profit civic innovation ecosystem that positions the region as the place innovators do business, showcases success in responsible AI advancement, supports digital equity and drives inclusive civic innovation. Bellevue actively seeks additional founding partners to support and enhance this mission.
2. Launching a second Innovation Challenge to partner with start-ups, community members, and students to enhance innovation in city services.
3. Continuing to enhance partnerships with the private sector and non-profits to expand digital equity initiatives.

4. Establish physical space in Bellevue to support innovative collaboration, pilots, start-ups, and small businesses. Create outdoor space that supports testing smart infrastructure in streamlined ways.
5. Expand AI education opportunities for government employees and the public to ensure everyone can take advantage of new opportunities.
6. Continue to host innovation events that support learning, networking, digital equity, and partnerships.
