EXECUTIVE SUMMARY

ACTION

This Resolution authorizes the execution of a three-year General Services Contract with All Stripes, LLC to provide traffic marking maintenance.

RECOMMENDATION

Move to adopt Resolution No. 10432

BACKGROUND/ANALYSIS

Traffic Marking Maintenance is vital towards providing clear and highly visible delineation for all road users including vehicles, bicyclists, and pedestrian traffic. This agreement will provide replacement of worn or otherwise damaged or missing crosswalks, directional arrows and raised pavement markers. Maintenance of traffic markings are needed to meet City and Federal standards, to reduce the probability of damages and claims, and to meet the City's customer service goals. Consistent with purchasing policies, an RFP was issued on September 5, 2024. Two contractors submitted quotes for annual estimated costs as follows:

All Stripes, LLC \$517,200.00

Specialized Pavement Marking, LLC \$943,500.00

Engineer's Estimate \$750,000.00

The low quote for this contract by All Stripes, LLC has been evaluated by staff and is considered to be balanced, fair, and competitive.

POLICY & FISCAL IMPACTS

Fiscal Impact

This action will obligate the City to a three-year General Services Contract with All Stripes, LLC for traffic marking maintenance in the amount of \$1,551,600.00, plus all applicable taxes. Sufficient funding is included in the 2025-26 Preliminary Transportation Department Operating Budget to fully fund the first two years of this contract. Additional funding associated with this contract will be requested in subsequent budgets and will be subject to final budget appropriation.
