## CITY OF BELLEVUE, WASHINGTON

## ORDINANCE NO. 6874

AN ORDINANCE amending Ordinance No. 5020, as subsequently amended by Ordinance No. 5472, to extend the existing boundaries of Residential Parking Permit Zone (RPZ) Zone 11; to delegate authority to the City Manager, or the City Manager's designee, to establish time-limited or time of day parking restrictions within RPZ 11; and to correct street names inaccurately or unclearly labeled in prior ordinances.

WHEREAS, City Council adopted Ordinance No. 5020 on September 15,1997 to address spillover parking and establish Residential Permit Parking Zone 11; and

WHEREAS, City Council adopted Ordinance No. 5472 on October 7, 2003, amending Ordinance No. 5020 to extend the boundaries of RPZ 11; and

WHEREAS, TR-137 of the Transportation Element of the Comprehensive Plan states that the City will "minimize non-residential parking in neighborhoods through residential parking zones and other measures"; and

WHEREAS, extending the boundaries of RPZ 11 would allow the City to expeditiously address spillover parking that may occur on streets adjacent to the existing boundaries of RPZ 11; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Ordinance No. 5020, as previously amended by Ordinance No. 5472 is amended to read as follows:

Section 1: The parking of vehicles on the following streets may be restricted to certain time limits or during specified times of the day, except by Zone 11 permit, when signs are present:

- A. SE 4th Place from 124th Avenue SE to 130th Place SE
- B. SE 5<sup>th</sup> Street from 129<sup>th</sup> Avenue SE to 130<sup>th</sup> Place SE
- C. 12900 block of SE 5th Place
- D. 12900 block of SE 6th Place
- E. SE 7<sup>th</sup> Place from 12523 SE 7<sup>th</sup> Place to 130<sup>th</sup> Place SE
- F. 128th Avenue SE from SE 4th Place to street end south of SE 7th Place
- G. 129th Avenue SE from SE 4th Place to SE 7th Place
- H. 130<sup>th</sup> Place SE from SE 4<sup>th</sup> Place to street end south of SE 7<sup>th</sup> Place

Section 2. The City Manager, or the City Manager's designee, is hereby authorized to establish time-limited parking or time-of-day parking restrictions on all or portions of the specific streets in Section 1, through the use of signs for vehicles without a Zone 11 permit.

Section 3. Parking restrictions allowed pursuant to this ordinance shall be filed and maintained with this Ordinance by the City Clerk in accordance with Bellevue City Code 11.23.010.
