It's like increasing minimum wage thinking that it will help, but it really won't because what it will do is cut jobs and owners of businesses will have to raise their prices in order to survive or go out of business. Those making minimum wage are often those who also eat at fast food places. They won't be able to buy those food any longer because prices have gone up and unaffordable and because they've had their hours cut due to increased minimum wage.
