Analysis of Proposed Speed Safety Camera Locations

Washington State Law (RCW 46.63.220(3)) requires that local jurisdictions evaluate any new or relocated speed safety camera with respect to "the impact of the camera placement on livability, accessibility, economics, education, and environmental health when identifying where to locate an automated traffic safety camera."

The law does not specify how jurisdictions should conduct this analysis. In consultation with the Washington Traffic Safety Commission, it was confirmed that the intent was to provide flexibility, allowing each jurisdiction to adopt an approach suited to its community context.

Accordingly, the following factors were identified to evaluate livability, accessibility, economics, education, and environmental health for Bellevue's Speed Safety Camera (SSC) expansion.

Livability

To assess livability, the team evaluated two factors:

- 1. The potential to **reduce road noise** through lower vehicle speeds.
- 2. The potential for **traffic diversion** to nearby streets that are not designed to accommodate additional volumes.

Road Noise:

Higher vehicle speeds generate greater road noise. Therefore, locations with posted speed limits above 35 mph are considered to have a *positive livability benefit* from SSC installation. No negative impacts to livability related to road noise are anticipated.

Traffic Diversion:

A qualitative review was conducted of the surrounding local street network near each SSC location. If a nearby parallel local street exists where drivers could divert—or if local drivers might use neighborhood streets longer to avoid the SSC—this is identified as a *negative livability impact*. Any diversion potential is considered a negative effect, even when offset by road noise benefits.

Accessibility

SSC proximity to schools, parks, and hospitals was used to assess accessibility.

Proximity to Schools, Parks, and Hospitals:

Any SSC located within 300 feet of a park or hospital, or within 500 feet of a school (measured via GIS around the parcel boundary), is viewed as having a *positive accessibility impact*. Locations near multiple sensitive land uses are considered very positive.

SSCs are not anticipated to have negative impacts on accessibility. All locations will undergo engineering review to ensure they do not obstruct sight lines or impede sidewalk access for people using mobility devices. Drivers adhering to the speed limit are not expected to experience reduced vehicular access.

Economics

Economic impacts were assessed based on two factors:

- 1. The **income levels** of nearby residents.
- 2. Whether the location lies within the **High Speeding Crash Network**.

Low-Income Residents:

GIS analysis identified candidate SSCs located within or adjacent to census block groups with a high concentration of households below the federal poverty line. The goal is to ensure SSCs are not disproportionately concentrated in low-income areas.

High Speeding Crash Network:

Fatal and serious injury (FSI) crashes have significant financial impacts on individuals, families, and the community. SSCs located on the High Speeding Crash Network—where speeding-related FSI crashes are most frequent—are considered to have a *positive economic impact*.

Final Economic Scoring:

- Potentially Negative: Located in a low-income area but not on the High Speeding Crash Network.
- *Mixed:* Located in a low-income area *and* on the High Speeding Crash Network.
- **Neutral**: Not in a low-income area and **not** on the High Speeding Crash Network.
- **Positive:** Not in a low-income area and *on* the High Speeding Crash Network.

Education

Educational impacts were evaluated based on proximity to schools and neighborhood educational attainment.

School Proximity:

SSCs within 500 feet of a public school are viewed as having a *positive impact*, as reduced speeds enhance safety for students walking or biking to school and may reduce noise and distraction during school hours.

Educational Attainment:

SSCs were evaluated based on their proximity to households with lower educational attainment (high school diploma or less). The goal is to ensure SSCs are not disproportionately concentrated in these areas.

Final Education Scoring:

- **Potentially Negative:** Located in an area with a high concentration of residents with lower educational attainment and *not* near a school.
- *Mixed:* Located in an area with a high concentration of residents with lower educational attainment and *near* a school.
- **Neutral:** Located in an area without a high concentration of residents with lower educational attainment and *not* near a school.
- **Positive:** Located in an area without a high concentration of residents with lower educational attainment and *near* a school.

Environmental Health

Environmental health considers how transportation conditions affect community well-being, particularly for people walking or biking. Two factors were analyzed:

- 1. Pedestrian Level of Traffic Stress (PLTS): This is a measure of how comfortable pedestrians and other sidewalk users are traveling along the sidewalk. The definition for PLTS comes from the Mobility Implementation Plan and is based on the dimensions of the sidewalk, the dimensions of a buffer (e.g., landscaping, parking, bike lanes) separating the sidewalk from traffic, the average daily traffic volumes, and the speed of adjacent traffic. PLTS is organized into four categories. PLTS 1 is the most comfortable, PLTS 4 is very uncomfortable, representing conditions where people will only walk if they absolutely must reach a destination along that route.
- **2. High Speed Streets:** Identifies whether the SSC is on a street where the 85th percentile speed exceeds 40 mph based on Jan-Mar 2024 data from Iteris ClearGuide data.

Pedestrian Level of Traffic Stress (PLTS):

SSCs located on roads with a PLTS of 3 or 4 are viewed as having a positive *environmental health impact*, as lower speeds reduce perceived stress and can encourage walking and physical activity.

High-Speed Streets:

SSCs on corridors with an 85th percentile speed of 40 mph or greater are viewed as having a *positive impact*, as the risk of fatal or serious injury rises significantly at higher speeds.

If both conditions are met (PLTS 3–4 and 85th percentile speed ≥40 mph), the impact is considered *very positive*.

Summary:

The tables below summarize how the 37 SSC locations scoring 60 or higher perform across the livability, accessibility, economic, education, and environmental health criteria described above.
