EXECUTIVE SUMMARY**ACTION**

This Motion will award Bid No. 25062 to AA Asphaltting, LLC for the On-Call Asphalt & Concrete Repair Contract.

RECOMMENDATION

Move to award Bid No. 25062 On-Call Asphalt & Concrete Repair Contract to AA Asphaltting, LLC.

BACKGROUND/ANALYSIS

This agreement for roadway and sidewalk surface repairs provides for the removal of temporary patches and installation of permanent asphalt and concrete. These permanent repairs are needed to meet City standards, to reduce the probability of damages and claims, and to meet the City's customer service goals. This contract provides permanent asphalt pavement and concrete walkway repairs to aging infrastructure on City streets. The on-call contract also provides for expedited services in making repairs to infrastructure at reduced costs.

Following verification of bid submittals, the bids received were as follows:

To the best of our knowledge and professional judgment, all factors that typically contribute to construction expenses have been accounted for in the Specifications and Estimates. All claims are rigorously reviewed and only those that are clearly necessary to accomplish the intent of the contract, but have not previously been provided for, will be paid.

POLICY & FISCAL IMPACTS

Policy Impact

Bellevue City Code 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required to award the bid where the cost exceeds \$350,000.

Fiscal Impact

Awarding this bid will obligate the City to a three-year maximum contract in an amount up to \$1,728,425, plus all applicable taxes, with AA Asphaltting LLC.

Sufficient funding exists in the 2025-2026 adopted operating budget for the first year of the contract. Funding for the remaining years of the contract will be requested in future budgets and will be subject to final budget appropriation.

1. Award Bid No. 25062, On-Call Asphalt and Concrete Repair Contract to AA Asphaltting, LLC. as the lowest responsible and responsive bidder, for a three-year contract in an amount not to exceed \$1,728,425, plus all applicable taxes.
