

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6826

AN ORDINANCE 1) authorizing execution of a grant agreement (and supplements if necessary) with the Washington State Department of Transportation (WSDOT) to accept up to \$628,000 in federal Highway Safety Improvement Program (HSIP) funding to support design and construction of the NE 8th Street Complete Streets Safety Improvements Project, 2) amending the 2025-2030 General Capital Improvement Program (CIP) Plan to increase the budget for the Vision Zero Rapid Build Data Driven Safety Program (CIP Plan No. PW-R-205) by \$628,000, 3) amending the 2025-2026 General CIP Fund to increase the appropriation by \$105,000; 4) providing for severability; and 5) establishing an effective date.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or designee is authorized to execute a grant agreement with the Washington State Department of Transportation (WSDOT) to accept up to \$628,000 in federal Highway Safety Improvement Program (HSIP) funding to support design and construction of the NE 8th Street Complete Streets Safety Improvements Project, a copy of which grant agreement shall be substantially in the form given Clerk's Receiving No. \_\_\_\_\_.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said Grant Agreement and shall have all authority necessary to enter into agreements regarding the use thereof.

Section 3. The 2025-2030 General Capital Investment Program (CIP) Plan adopted by Ordinance No. 6822 on November 19, 2024, is hereby amended to increase the budget for the Vision Zero Rapid Build Data Driven Safety Program (CIP Plan No. PW-R-205) by \$628,000.

Section 4. The 2025-2026 General CIP Fund adopted by Ordinance No. 6822 adopted on November 19, 2024, is hereby amended to increase the appropriation by \$105,000.

Provided, however, if the actual revenue received from the anticipated source specified in said Grant Agreement shall be more or less than the anticipated amount set

forth herein, the appropriations shall be adjusted to be equal to the amount actually received.

Section 5. Severability. If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining parts of this Ordinance.

Section 6. This Ordinance shall take effect and be in force five (5) days after its passage and legal publication.
