Bike Bellevue Public Process

August 6 2024

Mayor, Deputy Mayor, Councilmembers;

I was nonplussed reviewing the August 6 2024 Bellevue City Council meeting agenda; the Bike Bellevue presentation by Staff is only information and does not ask for direction.

I sincerely hope the agenda notice is adhered to in the meeting; any deviation would be a lack of government transparency to the public.

I hope that Council supports the decision of the Transportation Commission to only consider taking of traffic lanes on arterials as a last resort. The Transportation Commission took deliberate care to consider the public input on Bike Bellevue; to support the public process and the intense work the Commission has accomplished; Council must support their decision. The Transportation Commission advises the City Council on transportation-related issues. Members are responsible for studies, analyses and reports required by the Traffic Standards Code or requested by the council. If the Council overrides the vote of the Transportation Commission, there is no need to have Commissions and Boards.

I certainly hope that Council follows the agenda and only gives input, not direction to Staff. I have seen recent Council meetings be redirected at the last minute which does not give the public nor Councilmembers enough time to react and give input.

Bike Bellevue sounded like a good idea when it was initially introduced. I especially appreciated then-Councilmember Jennifer Robertson's direction for Staff to consider buying right of way to expand separated bike lanes. Having biked around Bellevue for many years, and voted on the latest Bike Ped plan, I thought Bike Bellevue would complete and enhance existing bike infrastructure. The idea of taking designated Truck and Commuter lanes for bike lanes goes against every traffic safety notion; especially considering the unanimous TR2 amendment to the Transportation Element of the Comprehensive Plan just a couple years ago that mandates aggressive investment to reduce traffic congestion. Taking out heavily traveled truck and commuter lanes at any part of the Bel Red corridor - or any arterial for that matter - will increase congestion and decrease traffic safety for all modes.

I implore Council to support its Transportation Commission and honor their decision.
