CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6854

AN ORDINANCE amending Chapter 1.16 Enforcement Provisions, Chapter 4.03 Tax Administrative Code and Title 10 Criminal Code of the Bellevue City Code, to update and recodify criminal violations and to update definitions, citations, procedures and other provisions related to criminal offenses, for consistency with state statutes codified in the RCW; providing for severability; and establishing an effective date.

WHEREAS, RCW 35A.12.140 permits the City to adopt by reference sections of Washington state statutes creating misdemeanor and gross misdemeanor crimes; and

WHEREAS, pursuant to RCW 35A.12.140, the City adopted Ordinance No. 6745 adopting by reference in Chapter 10.02 BCC sections of Washington state statutes creating misdemeanor and gross misdemeanor crimes as they were "currently enacted or as hereafter amended or recodified from time to time"; and

WHEREAS, when adopting such state statutes, the city council declared in BCC 10.00.010.E that "the city intends to assume jurisdiction over and become the jurisdictional authority for the enforcement and prosecution of misdemeanor and gross misdemeanor crimes committed within the city of Bellevue"; and

WHEREAS, the Bellevue City Attorney's Office prosecutes misdemeanor and gross misdemeanor crimes which have been adopted by reference in the BCC that occur within the City of Bellevue; and

WHEREAS, since the adoption of Ordinance No. 6745, the Washington State Legislature has created new gross misdemeanor crimes; and

WHEREAS, from time to time, the Washington State Legislature also has modified various definitions, citations, procedures and other provisions in the RCW related to criminal offenses, which have resulted in corresponding language in the BCC to be outdated and inconsistent; and

WHEREAS, in order for the Bellevue City Attorney's Office to continue to effectively prosecute all misdemeanor and gross misdemeanor crimes occurring within the city limits, the City must amend Chapter 1.16 Enforcement Provisions, Chapter 4.03 Tax Administrative Code and Title 10 Criminal Code of the Bellevue City Code, to update and recodify criminal violations and to update definitions, citations, procedures and other provisions related to criminal offenses, for consistency with state statutes codified in the RCW; and

WHEREAS, this Ordinance will protect the health, safety and welfare of the people in Bellevue; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. <u>Amend.</u> Subsection 1.16.010.C in Section 1.16.010 – Enforcement terms defined, of the Bellevue City Code is hereby amended to read as follows, with all other provisions in Section 1.16.010 that are omitted below, as indicated by ellipses, remaining unchanged:

1.16.010 Enforcement terms defined.

The following words, whenever used in the ordinances in the city, shall be construed as defined in this section unless from the context a different meaning is specifically defined:

C. "Gross misdemeanor" means any crime punishable by a fine not exceeding \$5,000, or imprisonment not exceeding 364 days, or both, unless otherwise specifically defined.

Section 2. <u>Amend.</u> Section 4.03.220 – Unlawful actions – Violation – Penalties, of the Bellevue City Code is hereby amended to read as follows, with all other provisions of Section 4.03.220 that are omitted below, as indicated by ellipses, remaining unchanged:

- B. Violation of any of the provisions of this chapter is a gross misdemeanor. Any person convicted of a violation of this chapter may be punished as provided by Title 10 BCC. Penalties or punishments provided in this chapter shall be in addition to all other penalties provided by law.
- C. Any person, or officer of a corporation, convicted of continuing to engage in business after the revocation of a license shall be guilty of a gross misdemeanor and may be punished as provided by Title 10 BCC.

Section 3. <u>Amend.</u> Subsection 10.00.010.M.1 in Section 10.00.010 – Preliminary article, of the Bellevue City Code is hereby amended to read as follows, with all

other provisions of Section 10.00.010 that are omitted below, as indicated by ellipses, remaining unchanged:

10.00.010 Preliminary article.

- M. Unless otherwise provided in this title, violation of any provision of this title shall be punishable by:
 - 1. Gross Misdemeanor. Every person convicted of a gross misdemeanor shall be punished by imprisonment in jail for a maximum term fixed by the court of not more than 364 days, or by a fine in an amount fixed by the court of not more than \$5,000, or by both such imprisonment and fine.

Section 4. <u>Amend.</u> Subsections 10.02.010.A and 10.02.010.B of Section 10.02.010 – Adoption of RCW sections not specifically set forth, of the Bellevue City Code are hereby amended to read as follows, with all other provisions of Section 10.02.010 that are omitted below, as indicated by an ellipsis, remaining unchanged:

A. With the exception of the RCW section set forth in subsection C of this section, all state statutes codified in the RCW that constitute misdemeanors and gross misdemeanors and the state statutes codified in the RCW related to the investigation of, arrest for, prosecution of, sentencing for, confinement for, definitions of terms for, defenses to, and enforcement of misdemeanors and gross misdemeanors are hereby adopted by reference as currently enacted or as hereafter amended or recodified from time to time, and shall be given the same force and effect as if set forth herein in full.

B. All class C felony crimes set forth in state statutes codified in the RCW are hereby adopted by reference for the purposes of charging a gross misdemeanor for a violation of any of the crimes set forth in Chapter 9A.28 RCW. The adoption of class C felonies shall be subject to the provisions of subsection A of this section and of Chapter 10.00 BCC.

Section 19. Severability. If any section, subsection, paragraph, sentence, clause, or phrase of this ordinance is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining parts of this Ordinance.

Section 20. Effective Date. This Ordinance shall take effect and be in force thirty (30) days after adoption and legal publication.
