(1) Councilmember Robinson is in process of selecting a new commissioner to fill the vacant position, (2) Commissioner elections will be moved from January to June to align with other Boards & Commissions, (3) The application period for the Human Services general fund are now open through April 6, 2026, and (4) Upcoming meetings April-June are particularly important due to commission preparation, review, and deliberations for human services funding.

A. Equity in Funding Training

Ruth Blaw shared remarks on behalf of Councilmember Robinson thanking the commission and emphasizing the importance of the equity training for the human service funding process they are about to begin. Ruth Blaw facilitated an ice breaker for commissioners and welcomed the trainer for the equity training, PCS DEI Program Administrator, Douglas Raiford.

Douglas Raiford guided the commissioners in a training that (1) explored how implicit bias operates, (2) examined its effects on community organization funding, and (3) developed practical tools and strategies to identify and eliminate bias in the decision-making process.
