




2025-2030 TIP Background






2025-2030 TIP Transportation Planning & Programming Process

2025-2030 TIP The four sections of the TIP

Recommended project list divided into four sections containing 113 projects

- Section I 39 projects included in the adopted 2023-2029
 Capital Investment Program (CIP)
- Section II 37 projects included in the adopted 2022-2033 Transportation Facilities Plan (TFP)
- Section III 32 other unfunded local projects identified and scoped by completed Alternative Analyses and Planning or Pre-design Studies
- Section IV 5 regional or outside agency-led projects in which the City may choose to participate financially

Recommended changes to the project list by section:

- Section I Two new sub-projects; one transferring sections; four projects removed
