





2021-2026 Transportation Improvement Program (TIP)

Proposed project list divided into four sections containing 104 projects

- **Section I** – 35 projects included in the adopted 2019-2025 Capital Investment Program (CIP)
- **Section II** – 31 projects included in the adopted 2019-2030 Transportation Facilities Plan (TFP)
- **Section III** – 34 other unfunded projects identified through the Comprehensive Transportation Project List or scoped by completed alternative analyses and planning/pre-design studies
- **Section IV** – 4 regional or outside agency-led projects in which the City may choose to participate financially

2021-2026 Transportation Improvement Program (TIP)

Proposed changes to the 2020-2025 project list by section:

- **Section I** – one project removed
- **Section II** – one project removed
- **Section III** – eight new projects; one project removed
- **Section IV** – three project descriptions revised; two projects removed
