





Program Overview


- Program approved in July 2024




1. KidsQuest

- \$400,000 for a Capital Project
- Remodel existing Water Gallery for new exhibit: Stories of Water from a Native lens



2. Theatre33

- \$462,500 for a Capital Project
- Phases two and three of theatre construction



3. Theatre33

- \$87,500 for Maintenance
- Purchase and install air conditioning



4. American Asian Performing Arts Theatre (AAPAT)

- \$600,000 for a Capital Project
- Construction of a 2,400 square feet dance studio expansion



5. Bellevue College Foundation

- \$250,000 for Maintenance
- Carlson Theatre updates and maintenance


