This project is fully funded through a \$1.24 million Highway Safety Improvement Program (HSIP) grant award from WSDOT and will be implemented through CIP Plan No. PW-R-46 Major Safety Improvements Program.

EXECUTIVE SUMMARY

ACTION

This Motion will award Bid No. 24118 to Always Active Services, LLC. for Coal Creek Parkway Corridor Safety Improvements.

RECOMMENDATION

Move to award Bid No. 24118, Coal Creek Parkway Corridor Safety Improvements (CIP Plan No. PW-R-46), to Always Active Services, LLC.

BACKGROUND/ANALYSIS

On September 13, 2022, the City was selected for an award of \$1.24 million in State funding through WSDOT's Highway Safety Improvement Program (HSIP) grant program that supports the City in implementing safety improvements along Coal Creek Parkway SE between Factoria Boulevard SE and the south city limits. Staff applied for grant funding for safety improvements due to a history of fatal and serious injury crashes along Coal Creek Parkway SE. The HSIP grant award for this project commits to several safety improvements including installing several speed radar feedback signs and upgrading curve warning signs along the corridor. On January 9, 2023, Council accepted this grant award (Ordinance No. 6710) to support the design and construction of the Coal Creek Parkway Corridor Safety Improvements project. The grant funding for this project will be distributed and paid out though CIP Plan No. PW-R-46 Major Safety Improvements Program.

All claims are rigorously reviewed and only those that are clearly necessary to accomplish the intent of the contract, but have not previously been provided for, will be paid.

POLICY & FISCAL IMPACTS

Policy Impact

Comprehensive Plan:

- TR-50. Maintain and enhance safety for all users of the street network
- TR-52. Maintain a collision reduction program to identify high collision locations, evaluate and prioritize potential safety improvements and implement recommended changes
- TR-56. Assess arterial speed limits and address concerns related to safety through appropriate speed limits, countermeasures and other techniques.
- TR-58. Strive to eliminate traffic deaths and serious injuries on Bellevue streets by 2030 in accordance with the Vision Zero Strategic Plan.

Fiscal Impact

Awarding this bid will obligate the City to \$647,600.00, plus all applicable taxes, to construct speed radar feedback signs, replace curve warning signs, and replace speed limit signs. This amount is approximately 13 percent under the Engineer's Estimate.

Funding for this project is included in the 2025-2030 General Capital Improvement Program (CIP) Fund in the Traffic Safety Implementation program (CIP Plan No. PW-R-46). This contract is fully funded on a reimbursable basis through the \$1.24 million HSIP grant award from WSDOT.

OPTIONS

- 1. Award Bid No. 24118, Coal Creek Parkway Corridor Safety Improvements (CIP Plan No. PW-R-46), to Always Active Services, LLC. as the lowest responsible and responsive bidder, in the amount of \$647,600.00, plus all applicable taxes.
- 2. Award the bid to the next lowest bidder if the low bidder is not responsive.
- 3. Reject all bids and provide alternative direction to staff.
