Support may also include sleeping accommodations, hygiene facilities, meals, and connection to additional resources.	34.71%	35.00%	
<b>Financial Assistance</b>  Programs and service that provide direct support to low- or moderate-income households to help cover essential expenses such as rent, utilities, transportation, and critical needs.	5.68%	6.00%	
<b>Food &amp; Basic Needs</b>  Programs and services that provide access to food and essential daily needs for individuals and families experiencing economic hardship. In addition, these services may include hygiene items such as diapers and toiletries.	9.40%	10.00%	
<b>Housing Stability</b>  Programs and services designed to prevent or interrupt homelessness and support safe, stable housing.	5.98%	6.00%	
<b>Survivor Advocacy &amp; Safety from Violence</b>  Programs and services that provide support, advocacy, and prevention resources to individuals affected by abuse in their relationships, households, or community.	1.95%	2.00%	
<b>Behavioral Health</b>  Programs and services that prevent, diagnose, treat, and support individuals with mental health conditions, emotional challenges, and substance use disorders.	18.21%	18.00%	
<b>Childcare &amp; Early Learning</b>  Programs and services that provide safe, nurturing, and developmentally appropriate care, education, and support for children or help households find and maintain childcare.	8.05%	7.00%	
<b>Medical &amp; Dental</b>  Programs and services that support physical health through access to essential medical and dental care.	1.14%	1.00%	
<b>Navigation, Legal, case management &amp; other supportive services</b>  Programs and services that provide personalized support and resources help individuals access and navigate the human services system. These services may include legal advice, representation, and case management.	9.07%	9.00%	
<b>Fostering Well-being in the face of hate, bias and discrimination</b>  Programs and services that promote safety, resilience, and empowerment for individuals and communities impacted by racism, discrimination, and bias.
