EXECUTIVE SUMMARY

This Resolution authorizes execution of an agreement with Great Western Recreation for the demolition of existing play equipment and the purchase and installation of new play equipment at Cherry Crest Mini Park.

RECOMMENDATION

Move to adopt Resolution No. 10048

BACKGROUND/ANALYSIS

Cherry Crest Mini Park was constructed in the late 1990s, and with more than 20 years of wear and tear has been scheduled for renovation. In 2018, the Neighborhood Enhancement Program solicited ideas for neighborhood improvement projects from the Bridle Trails Neighborhood, and refurbishment of the park was supported by the community. Updating the play equipment is a part of the work needed to renovate the park. The proposed new play equipment was selected in collaboration with the community and Great Western Recreation (GWR) design team. The new play equipment includes more play elements than the current equipment, fits within the existing playground footprint, and works with Cherry Crest's Park water theme. The playground is designed to promote inclusivity and diverse play for children of all abilities. Routes of travel, surfacing and equipment are designed to be readily accessible. The new play structures will be accessible for children ages 2-12 with transition platforms, ground base play, climbing elements and swings (Attachment A).

GWR has a lengthy history of successfully installing playground equipment for the City of Bellevue Parks and nationwide. They were chosen by staff for the quality of their Gametime brand play equipment, installations, ability to customize design areas, and ability to meet the City's safety and accessibility standards.

The purchase of the GWR Gametime play equipment will be through the Omnia Partners purchasing program. Omnia Partners is a large cooperative purchasing program that serves public sector members, including the City, by providing competitively solicited municipal government contracts that meet Washington State and City of Bellevue bid law requirements.

POLICY & FISCAL IMPACTS

Policy Impact

Bellevue City Code 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required to award the bid where the cost exceeds \$90,000.

Fiscal Impact

Awarding this agreement obligates the City to an amount not to exceed \$111,658.09, plus all applicable taxes. The project will be funded by CIP Plan No. NEP-2 Neighborhood Enhancement Program and CIP Plan No. P-R-11 Renovation and the Refurbishment of Park Facilities as follows below. There are sufficient funds available to perform this work.
