EXECUTIVE SUMMARY**ACTION**

This Resolution authorizes the execution of a three-year General Services Contract with Specialized Pavement Marking, LLC to provide annual City-wide traffic striping maintenance.

RECOMMENDATION

Move to adopt Resolution No. 10385

BACKGROUND/ANALYSIS

Annual Paint Striping of the City's roadway is vital towards providing clear and highly visible delineation for all road users including vehicles, bicyclists, and pedestrian traffic. Traffic striping maintenance is needed to meet City and Federal standards, to reduce the probability of damages and claims, and to meet the City's customer service goals. Restriping takes place during the summer months between July and September and is completed approximately two weeks after the initial start date. Consistent with city purchasing policies, an RFP was issued April 11, 2024. A single submittal was received by Specialized Pavement Markings, LLC who at the time of the RFP posting, had just purchased its local competitor who was also expected to bid on this contract. Staff evaluated the proposal and Specialized Pavement Markings, LLC was considered to be a qualified contractor to perform this annual contracted service.

Fiscal Impact

This action will obligate the City to a three-year General Services Contract with Specialized Pavement Marking, LLC for City-wide traffic striping maintenance in the amount of \$871,531.98, plus all applicable

taxes. Sufficient funding exists in the 2025-26 Transportation Department Operating Budget to fully fund the first two years of this contract. Additional funding associated with this contract will be requested in subsequent budgets and will be subject to final budget appropriation.

OPTIONS

1. Adopt the Resolution authorizing the execution of a three-year General Services Contract with Specialized Pavement Marking, LLC, in the amount of \$871,531.98, plus all applicable taxes, to provide annual City-wide traffic striping maintenance.
2. Do not Adopt Resolution and provide alternative direction to staff.
