### **EXECUTIVE SUMMARY**

This Resolution authorized the execution of Supplement #5 of the Professional Services Agreement with HDR Engineering, Inc. to complete the engineering design and to prepare the construction contract documents for the 124<sup>th</sup> Avenue NE – Ichigo Way to Northup Way (CIP Plan No. PW-R-191) project.

### **RECOMMENDATION**

Move to adopt Resolution No. 10026

#### **BACKGROUND/ANALYSIS**

The 124<sup>th</sup> Avenue NE corridor improvements is divided into four segments: NE 8<sup>th</sup> Street to NE 12<sup>th</sup> Street has been completed; NE 12<sup>th</sup> Street to NE Spring Boulevard is in the construction phase; NE Spring Boulevard to Ichigo Way has been completed; and Ichigo Way to Northup Way is in the design phase. The 124<sup>th</sup> Avenue NE corridor improvements are part of the broad BelRed Plan and Transportation vision of supporting planned growth and economic vitality, improving access and circulation, and capturing synergistic opportunities with Sound Transit's East Link Project.

HDR Engineering, Inc. was originally selected to perform the design work for the 124<sup>th</sup> Avenue NE corridor under various contracts. This contract was created to complete the design and prepare the construction contract documents for 124<sup>th</sup> Ave NE, Spring Blvd to Ichigo Way (PW-R-166) and 124<sup>th</sup> Avenue NE, Ichigo Way to Northup Way (Plan No. PW-R-191).

The design development of the 124<sup>th</sup> Avenue NE corridor required lengthy and complex coordination with many stakeholders and impacted parties. This resulted in significant additional design, and design revision work, that were not foreseen under the original Professional Engineering Services Agreement, nor the subsequent supplements.

Some of the additional design work includes:

- New and revised design work to accommodate adjacent property owners and businesses, during the right-of-way negotiation and acquisition process.
- Additional geotechnical design and field investigation, after significant underground water was discovered within the project limits.

- Revisions to the wall design around the culvert to support the aquifer condition present at the site.
- Several changes to the culvert design to comply with the conditions of federal, state, and City project permits.
- Several design changes to accommodate adjacent private developments.
- Additional reviews and audits of the contract documents because of design updates and re-designs since the last design update was five years ago.

# **Fiscal Impact**

This action obligates the City to increase the contract with HDR Engineering, Inc. by \$535,327.00 for a total contract amount of \$2,074,793.97, plus all applicable taxes, to complete engineering design and prepare construction contract documents for the 124<sup>th</sup> Avenue NE – Ichigo Way to Northup Way. Sufficient funding exists in the 2021-2027 CIP (CIP Plan No. PW-R-191). The original contract and prior amendments were funded through PW-R-166 and PW-R-191. The supplement #3 and #4 were time extensions only.
