#### **Continuous Improvement**



### Areas where Commission is functioning well.

- Good questions and respectful discussion
- Moving policy decisions through the process
- Representing the community in decisions
- Meeting facilitation by Chair and welcoming feel to community
- Respect amongst Commissioners, and appreciation/respect of Staff
- Consistent attendance



### Improving Commission interaction.

- Discussion of "big picture" land use policy and interests
- More time to discuss issues and public comment
- Raise hand to provide Commissioner input and voting
- Opportunity for Consent Agenda for some items
- Get to know one another and learn about backgrounds
- More background materials and training



#### More effective staff support for Commission.

- Knowledge sharing to Commission on land use policy and City role in planning and permitting
- Timing of Commission receipt of meeting packet/public input (min. 5 days)
- Provide balanced perspective of policy choices
- Ensure trainings are scheduled for Commissioners
- Feedback to Commission to improve effectiveness on moving policy decisions forward
- Follow-up on Commission requests (e.g. public comment personal details)



### Improving interaction with the community.

- Information sharing and engagement with the public
- Involving additional, and new people in the process
- Continued and enhanced use of Zoom
- Addressing comments about disproportionate burden
- Allow for additional meeting following public hearings to form recommendations



#### Areas for improvement relating to the overall Commission function and interactions.

- Commission members more freely reaching out to staff
  with questions or needed background information
- Specific reference to Decision Criteria for CPAs and LUCAs when forming recommendations
- Input in forming and/or modifying staff recommendations
- Provide fully formed recommendations that avoid additional Council code/policy work prior to adoption
