AQUATIC CENTER FEASIBILITY STUDY

After Council's endorsement of the Preferred Concept Facility Plan authored by city staff and Splash *Forward*, staff is proceeding with project next steps to develop a fundraising agreement (Memorandum of Understanding) with Splash Forward. Staff has initiated processes to contract for design and engineering services to support the Bellevue Airfield Master Plan Update, a potential site for the aquatic facility.

ASHWOOD PARK MASTER PLAN UPDATE

Given vacancies of key positions in this and other city departments involved, the City Manager's Office has delayed the Ashwood Park master plan update. No date has been set to restart this work. Staff has previously reached out to all stakeholders that have been tracking this project to let them know the status.

BELLEVUE AIRFIELD PARK MASTER PLAN UPDATE

On October 18, 2021 Council identified the Bellevue Airfield Park site as a potential location for a new Aquatic Facility. Staff is initiating contract work to update the Master Plan and anticipates the updated master planning process (including public outreach and environmental review) to take approximately two years to conclude with Council's adoption of an Updated Bellevue Airfield Park Master Plan. Project information and regular updates will be available on the City's project website throughout the duration of the project.

BRIDLE TRAILS - NEW NEIGHBORHOOD PARK ON 140TH AVE

Construction documentation and permitting work is in-process, and on-site construction is estimated to begin early 2023. Berger Partnership is assisting staff with architecture, engineering, and permit work. Staff is working to keep the Bridle Trails Community Club up to date on project process.

DOWNTOWN PARK - NE GATEWAY CONSTRUCTION

Ohno-Touchdown JV Construction has installed the additional new lighting in the existing formal garden and are working to install the requested new metal railing and water feature grate revision. The NE Gateway work is under warranty and any start-up issues have been completed. The Gateway and Plaza construction was opened to the public the first week of June and the City's new public art sculpture should be ready for installation in 2022.

ENATAI BEACH PARK - BOATHOUSE RENOVATION

On September 7, 2021, Council approved execution of a publicly bid contract with Reynolds General Contracting, Inc. to replace the roof of the Enatai Boathouse. Publicly bid contract work included roof replacement and repair and/or replacement of some damaged structural elements. Demolition of the roof this fall has exposed additional extensive water damage and dry rot of the wood glulam beams and structural wood deck than was originally evident. Additional replacement of damaged structural elements is needed. Roof work is anticipated to be completed late spring 2022.

HEARING ACCESSIBILITY FOR PUBLIC SPACES

The project involves installing and updating hearing assistance systems in six park facilities: North Bellevue, Highland, Crossroads, South Bellevue Community Centers, the Bellevue Botanical Gardens and Northwest Arts Center. Work has been completed to expand listening assistance services at North Bellevue, and Highland Community Centers, the Botanical Garden Gift Shop, and the Northwest Arts Center. Staff is working with I.T. to ensure compatibility with city-wide audio-visual systems to finish up remaining work at South Bellevue Community Center, and the Bellevue Botanical Garden.

MEYDENBAUER BAY PARK PHASE II DESIGN

The initial objective of the Meydenbauer Bay Park Phase II Design project is to determine the scope of work to be included in this next phase of development. This project is currently on hold. Work to select an architectural and engineering team to assist the City with studies and community outreach will be re-initiated in 2022 when City staff resources across departments are available to help support Phase II planning. Staff is looking forward to working with the Community to inform our next steps towards realizing the Meydenbauer Bay Park Master Plan, and implementation principles. Public engagement is anticipated to begin later in 2022.

NEWPORT HILLS WOODLAWN PARK

At their December 13th meeting, Council concurred with the Parks & Community Services Board recommendation and community preferences directing staff to return with a resolution to name the new park in the Newport Hills Neighborhood "Newport Hills Woodlawn Park". Construction of the new park was publicly bid and on September 7th the City Council awarded the construction contract to Terra Dynamics. Construction began in early October and is anticipated to be complete Summer 2022.

PARK OPERATION AND MAINTENANCE FACILITY

As part of a City-wide initiative, staff is working to inform design and development of a new park operation & maintenance facility. Current park facilities housing these functions are inefficient and inadequate in size with obsolete failing infrastructure. On November 22, 2021 Council awarded the architecture and engineering services contract to a team lead by ARC Architects. Planning and design work is underway.
