EXECUTIVE SUMMARY

This Resolution authorizes Parks & Community Services to contract for maintenance and minor repairs for sport courts throughout the Bellevue parks system.

RECOMMENDATION

Move to adopt Resolution No. 10082

BACKGROUND/ANALYSIS

Parks has chosen Novacrylic as the surface coating standard for Bellevue's sport courts, including tennis, pickleball, and basketball courts. Mid Pac Construction Inc. is certified by a Nova Sports U.S.A. Inc. (the manufacturer of Novacrylic) as a product distributor and applicator for Washington state.

On January 26, a Notice of Intent (N.O.I.) to contract with Mid Pac Construction Inc. for sport court maintenance and minor repair services was published in the Seattle Times and the Daily Journal of Commerce. The N.O.I. closed on February 9 with no responses that any other company could meet the specifications required.

POLICY & FISCAL IMPACTS**Policy Impact**

PA-34. Evaluate existing parks and facilities, renovate, where appropriate, to maximize efficient maintenance and operation practices, improve safety and accessibility for all user, and to reduce, where feasible, the impacts on adjacent properties.

Bellevue City Code 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required to award the bid where the cost exceeds \$90,000.

Fiscal Impact

This action will obligate the City to an amount not to exceed \$125,000 plus applicable taxes. These repairs are funded through (CIP Plan No. P-R-11) Renovation and Refurbishment of Park Facilities. Sufficient funds have been budgeted in the 2021-2027 Capital Investment Program to cover these costs.

OPTIONS

1. Adopt the Resolution authorizing the execution of a Purchase Order with Mid Pac Construction Inc. for sport court maintenance and minor repairs in an amount not to exceed \$125,000, plus applicable taxes.
2. Do not adopt the Resolution and provide alternative direction to staff.
