Definitions

- BIPOC: An abbreviation for Black, Indigenous, (and) People of Color. POC is widely used as an umbrella term for all people of color. BIPOC recognizes that Black and Indigenous people are severely impacted by systemic racial injustices.
- BIPOC By and For Agencies: Agencies that were created by, are led and staffed by and focus on serving a BIPOC community(ies). BIPOC By and For Agencies provide culturally and linguistically specific services.



Human Services Funding Allocated in 2020 & 2021

- Since 2020, City of Bellevue has allocated \$14 million dollars in pandemic and 1590 funding, in addition to the \$4.5 million of ongoing human service.
- During the pandemic, the City Council emphasized to the Human Services Commission to form recommendations including both a wide base of agencies and agencies providing culturally specific services.

BIPOC By and For Programs Funded

All 2020 and 2021 human services funding:

- 2020: 13% (11 of 83) of programs funded are BIPOC By and For programs, which includes 4 new programs.
- 2021: 22% (20 of 91) of programs funded are BIPOC By and For programs, which includes 7 new programs.

Just 2021-2022 COB Human Service Fund cycle funding:

• 13 of the 82 programs (16%) funded are BIPOC By and For programs.





Agencies Funded for the First Time

All human service funding grantees in 2020 and 2021 that were funded for the first time:

- 2020: 7% (3 of 44) of all agencies funded (Community Homes, Inc., Bellevue LifeSpring and MAPS-MCRC)
- 2021: 4% (2 of 49) of all agencies funded 4 Tomorrow and Centro Cultural Mexicano)

Just 2021 - 2022 COB Human Service Fund cycle grantees who were funded for the first time:

• 4% (2/48) of all agencies (4 Tomorrow and Families of Color Seattle)



Funding for Eastside-born and Eastside-based Agencies

All human services agencies funded:

- 2020: 50% (22 of 44) agencies that received were Eastside-born and Eastside-based.
- 2021: 51% (25 of 49) agencies that received were Eastside-born and Eastside-based.

Just agencies funded in the 21-22 COB Human Service Fund cycle:

• 49% percent (24 of 49) agencies that received funding are Eastside-born and Eastside-based.



Efforts to Achieve Greater Equity in Funding

- Revised the financial documentation requirements to include only those mandated by state or federal law.
- Agencies that are not required to register at the state as a charitable organization or as a federal 501(c)3
- Offer Technical Assistance for Human Services Fund application processes
- Interpreters can/will be provided upon request at funding information sessions or any other city meeting to discuss human service funding.
- Bellevue accepts funding applications and quarterly reports in languages other than English.
- Funding a capacity building initiative through Communities Rise that will begin in June 2022.
- All Human Services Commissioners reviewing applications receive equity training.
