#### Federal Legislative Agenda

- Adopted in Spring 2022
- This is our compass
- The primary lens we use to assess both funding opportunities as they arise, as well as develop strategies to get traction on important priorities

#### **Earmark Update**

- Earmarks returned! More affectionately called Congressionally Directed Spending (Senate) or Community Project Funding (House)
- The 2022 round happened this spring for FY 2023
- Bellevue worked with departments in submitting requests :
  - Police

- Utilities


- Transportation

- Good news: Two of these requests are advancing!
- Feedback from Congressional delegation

#### **Bipartisan Infrastructure Law (BIL)**

Signed by President Biden on November 15, 2021

- Once-in-a-generation investment in infrastructure
- Administration priorities:
  - Equity
  - Climate and resiliency
  - Reaching all communities
  - Partnerships





## **BIL funding**

#### **\$1.2 trillion total**

**\$650B**: Reauthorizes *existing* surface transportation programs for FY 2022-2026

**\$550B**:Creates *new* formula, competitive and discretionary grant programs


#### Not just about transportation...



# How can cities receive BIL funds?

Two primary methods :

- Formula distribution: Funds distributed to Washington State, Puget Sound Regional Council or other authority (ex. transit)
- 2) Competitive programs: Apply for federal funds directly on our own or with eligible partners as a team

- Parks & Community Service
- Transportation
- Utilities



#### **Build relationships**



- Elected leadership
- Federal agency regional offices
- Stakeholders, including community-based organizations, advocacy organizations, businesses, community leaders
- Resource organizations, such as National League of Cities

- Developing a project pipeline
- Working to build support with partners
- Sharing our federal legislative agenda with delegation
- Highlighting key projects during August recess
- Planning a DC trip in the fall
