## EXECUTIVE SUMMARY

This Resolution will authorize Parks and Community Services to execute a contract for the demolition of existing play equipment and the purchase and installation of new play equipment at Eastgate Park at South Bellevue Community Center.

## RECOMMENDATION

Move to adopt Resolution No. 10131

## BACKGROUND/ANALYSIS

The current play equipment at Eastgate Park at South Bellevue Community Center was installed in 2005. It has reached its end of useful life, and repair/replacement parts are no longer available. Staff selected the proposed new play equipment after working with the South Bellevue Community Center staff and the design team. Several designs were evaluated based on inclusive play for 2-5- and 5-12-year-old children, ensuring that the new equipment meets the needs of the center's programming. The selected design adds more inclusive playground equipment than the existing structure, with a total of eight ground level accessible elements and an accessible pathway between the play structures.

The purchase of the equipment will utilize a cooperative agreement through the Sourcewell Purchasing program that allows the City to secure very competitive pricing.

## POLICY & FISCAL IMPACTS

### Policy Impact

The Parks, Recreation and Open Space element of the Bellevue Comprehensive Plan supports the purchase and installation of the new equipment.

Bellevue City Code (BCC) PA-34. Evaluate existing parks and facilities, renovate, where appropriate, to maximize efficient maintenance and operation practices, improve safety and accessibility for all users, and to reduce, where feasible, the impacts on adjacent properties.

BCC 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required to award the bid where the cost exceeds \$90,000.

**Fiscal Impact**

This action will obligate the City to pay an amount not to exceed \$215,263.04 plus all applicable taxes.

This project is funded in the 2021-2027 General Capital Investment Program (CIP) through CIP Plan No. P-R-11, Renovation and Refurbishment of Park Facilities. Sufficient budget exists in the 2021-2027 General CIP Parks Renovation & Refurbishment Plan (CIP Plan No. P-R-11) to fully fund this contract.

**OPTIONS**

1. Adopt the Resolution authorizing the execution of a contract with Landscape Structures Inc., in an amount not to exceed \$215,263.04 plus applicable taxes, for the demolition of existing playground equipment and the purchase and installation of new playground equipment at Eastgate Park at South Bellevue Community Center.
