Subject:	2022 Well Kids Environmental Project Training (K.E.P.T.) Program Brief

# **INTRODUCTION**

The City of Bellevue's Well K.E.P.T. (Kids Environmental Project Training) program has completed another successful summer serving the Bellevue community. For 34 years, Bellevue Parks & Community Services has engaged youth and invested in our city's future by providing valuable employment opportunities to Bellevue youth through Well K.E.P.T.

The Well K.E.P.T. program is a summer youth employment opportunity offered through the Bellevue Parks' Natural Resource Division. The program is designed to provide Bellevue youth with education, job skills, and career development training in the field of park resource management. The work focuses on parkland restoration and maintenance. This summer, typical projects included forest enhancement, trail construction, and farm maintenance. Well K.E.P.T. combines on-the-job work experience with environmental education and career development to instill strong self-esteem, good



work habits, and sound environmental ethics. Trainees developed and strengthened technical experience related to natural resource best management practices and trail construction techniques.

Well KEPT 2022 was funded by a King Conservation District (KCD) Member Jurisdiction Grant.

# **2022 PROJECTS & ACCOMPLISHMENTS**

**Trail Projects:** In addition to providing a valuable service to the Bellevue Park System, trail projects provide trainees with a hands-on opportunity to make a difference in their community. Through this experience, trainees gain a deeper understanding of the pivotal role integrated trails have in the holistic management of Bellevue's green spaces. Trainees developed a deeper understanding of Bellevue's natural environment while improving access within the park system.

- Renovated **2,785 ft** of hiking trails throughout the Bellevue Park System. This included regrading, graveling, and mulching trail.
- Removed and replaced a damaged agricultural drainage pipe in Mercer Slough Natural Area's Overlake Blueberry Farm.

**Noxious Weed Removal Projects:** *Removing unwanted noxious weeds from the Bellevue Park System helps develop an understanding of plant physiology, encourages a conservation ethic, introduces techniques of plant identification, and conveys the importance of urban forest management.* 

• Cleared **19,928 ft**<sup>2</sup> of noxious weeds throughout the Bellevue Park System. This included species such as orange spotted jewelweed, tansy ragwort, English ivy, and Himalayan blackberry.

# **PROFESSIONAL DEVELOPMENT WORKSHOPS**

The Well K.E.P.T. training program provides valuable educational opportunities to participants. Educational seminars and workshops provided the students with deeper knowledge regarding their projects, developed their environmental awareness, and honed their professional skills. Seminars and workshops completed during the 2022 season are listed below:

- Forest management
- Resume & cover letter workshop
- Mock interviews
- Native plant species
- Invasive plant species
- Aquatic invertebrates & stream health
- Wildlife science

- Improved quality of local greenspaces adjacent to neighboring communities


#### **CONCLUSION**
