EXECUTIVE SUMMARY

This agreement allows City employees to use a single card known as “ORCA” to access comprehensive transportation services provided by King County Metro, Sound Transit, Pierce Transit, Community Transit, Everett Transit, and Kitsap Transit. The City’s Commute Trip Reduction (CTR) program relies on ORCA cards to support and incentivize employees to commute by sustainable modes.

RECOMMENDATION

Move to adopt Resolution No. 10177

BACKGROUND/ANALYSIS

As the administrator for CTR for Bellevue employers, the City promotes the ORCA card program as an effective CTR tool. When the ORCA card is included in an employer’s CTR program, it is associated with an increase in the transit and vanpool use among its employees. Providing the ORCA card as one of the City’s CTR program elements helps the City comply with its own regulatory requirements and supports employees in commuting to work using sustainable modes. The ORCA cards issued to City of Bellevue employees are valid for full fares and unlimited rides on:

- Bus (King County Metro, Sound Transit, Community Transit, Everett Transit, Pierce Transit, Kitsap Transit)
- Ferry (King County water taxi, Kitsap local ferries and fast ferries)
- Rail (Sound Transit Link light rail, Sound Transit Sounder including Rail Plus partnership with Amtrak Cascades)
- Paratransit Transportation (King County Metro Access, Kitsap Transit Access, Pierce Transit Shuttle)
- Seattle Streetcar
- Seattle Monorail

To be eligible to participate in the ORCA card agreement, the City is required to provide ORCA cards to all of its CTR-affected employees (employees arriving to work between 6:00-9:00 a.m.). Therefore, the 2023 ORCA card agreement is for the use of 1,300 ORCA cards for employees.

POLICY & FISCAL IMPACTS

Policy Impact

Prior Direction from Council

In February 2007, the City Council passed Resolution No. 7517, adopting a goal of reducing greenhouse gas emissions. Providing ORCA cards as part of the City's CTR program supports more use of transit and other sustainable modes by employees and thus helps the City further its emission reduction goal.

State Law/Bellevue City Code

The State Transportation Demand Management law (RCW 70A.15.4040) requires employers with 100 or more employees to develop a CTR program that encourages its employees to reduce drive alone commute trips and vehicle miles traveled. Bellevue City Code 14.40 and the State law require affected employers to make a good faith effort as identified in RCW 70A.15.4050 to develop and implement a CTR program.

Comprehensive Plan

Bellevue's Comprehensive Plan, Policy TR-12 states: "Ensure that the City as an employer sets a positive example by maintaining a comprehensive and effective transportation demand management program for its employees." By providing ORCA cards, the City provides employees alternatives to drive alone commuting and sets a positive example to other Bellevue employers.

Fiscal Impact

Approval of this action obligates the City to pay King County up to \$215,000, plus all applicable taxes, for the purchase of the annual 2023 ORCA cards for City employees. ORCA costs are calculated using a fixed price for vanpools and administrative services and the projected volume of employee ridership. The projected volume of employee ridership are best estimates using current data and information available. The City will only pay for actual transit ridership.

At \$215,000 the ORCA card agreement continues to be a cost-effective option for the City, and it provides employees access to comprehensive transportation benefits that combine bus, vanpool and vanshare, rail, streetcar, water taxi, and emergency taxi ride features all in one program.

This expenditure was planned and budgeted in the adopted 2023-2024 Facilities Services Fund operating budget.

OPTIONS

1. Adopt the Resolution authorizing execution of the annual ORCA card agreement with King County for the purchase of ORCA cards for City of Bellevue employees for 2023, in an amount not to exceed \$215,000, plus all applicable taxes.
2. Do not adopt the Resolution and provide alternative direction to staff.
