EXECUTIVE SUMMARY

This Resolution authorizes execution of an amendment to the Professional Services Agreement with Pacifica Law Group LLP for continued representation related to the acquisition of property rights needed for the Transportation CIP projects involving the widening of 124th Avenue NE from NE 12th Street to Northup Way (CIP Plan No. PW-R-166, PW-R-169, PW-R-191).

RECOMMENDATION

Move to adopt Resolution No. 10199

BACKGROUND/ANALYSIS

As part of the City's long-range CIP Transportation plan, the City is in the process of widening and reprofiling 124th Avenue NE in three construction phases, each of which is a separate CIP project. The first phase of the expansion (NE Spring Boulevard to Ichigo Way, PW-R-166) has been completed in conjunction with Sound Transit's East Link Project. Although all of the necessary property rights have been obtained for this first construction phase, the City needs the assistance of Pacifica Law Group to close out the cost share agreement with Sound Transit for this work.

Pacifica Law Group has assisted in obtaining the necessary property rights for the second and third construction phases of the project (PW-R-169 and PW-R-191) allowing construction of these phases to proceed. These projects are being constructed. However, just compensation has not been agreed to for nine parcels which will require further representation from Pacifica Law Group at mediation and/or potentially at trial if settlement is unsuccessful.

A Professional Services Agreement in the amount of \$230,000, plus applicable sales tax, was approved by the City Council on February 19, 2019, to continue the legal services necessary for completion of the first construction phase of the 124th Avenue NE road widening project and to assist in the acquisitions necessary for the remaining two construction phases. Additional funds are necessary to resolve just compensation on the remaining parcels.

POLICY & FISCAL IMPACTS

Policy Impact

Bellevue City Code 4.28.040 provides that professional services contracts in excess of \$90,000 require Council approval.

Fiscal Impact

This action obligates the City to increase the Professional Services Agreement with Pacifica Law Group LLP, in an amount not to exceed \$300,000, plus all applicable taxes, for legal services for the acquisition of the property rights needed for the Transportation CIP projects widening 124th Avenue NE from NE 12th Street to Northup Way.
