Hi Renay Bennett,

I appreciate you taking the time to share your thoughts regarding development within the City of Bellevue and the Master Plan update for Bellevue Airfield Park. Maintaining a high-quality park system depends on the community's, your participation. Environmental stewardship is a core value for the City of Bellevue and is intrinsic to building a healthy economy, healthy communities, and a healthy planet. Enhancing and protecting the City's natural resources, water, air, climate, parks, and open spaces for future generations is a high priority.

Our work in the Park Department strives to build a healthy community through an integrated system of exceptional parks, natural areas, recreation, arts and culture, and a broad base of community services. The pristine natural conditions that existed in our region 120 years ago have been radically altered by development, Bellevue Airfield Park is one of those very altered properties having been used as an Airfield (until 1983) and a municipal landfill from 1951 to 1964. We look forward to improving the existing landfill systems and environmental conditions when development of the park occurs.

In 2002, Council authorized the purchase of the properties now known as Bellevue Airfield Park. The City of Bellevue recognized that the site likely represented the last opportunity to acquire a large, undeveloped, relatively flat parcel of property in Bellevue. The acquisition of the properties was purchased for the purpose of providing a community-wide park with active recreation. This site represents the only City-owned site large enough to accommodate an aquatic facility. All current proposed Master Plan options for park development have been directed by community input, strive to protect, and enhance existing tree canopy and habitat. Active recreation is located to the southern portion of the property over the former landfill.
