






2024-2029 TIP Transportation Planning & Programming Process

2024-2029 TIP The four sections of the TIP

Recommended project list divided into four sections containing 111 projects

- Section I 40 projects included in the adopted 2023-2029 Capital Investment Program (CIP)
- Section II 37 projects included in the adopted 2022-2033 Transportation Facilities Plan (TFP)
- Section III 29 other unfunded local projects identified and scoped by completed Alternative Analyses and Planning or Pre-design Studies
- Section IV 5 regional or outside agency-led projects in which the City may choose to participate financially

Recommended changes to 2023-2028 TIP

Recommended changes to the project list by section:

- Section I Seven new projects; three projects removed
- Section II Nine projects transferring sections
- Section III Two new projects
- Section IV No change
