# **EXECUTIVE SUMMARY**

This Resolution authorizes execution of an amendment to the Professional Services Agreement with Pacifica Law Group for the continued representation of the City in the investigation, response, and litigation related to the January 17, 2022 landslide.

#### RECOMMENDATION

Move to adopt Resolution No. 10256

#### BACKGROUND/ANALYSIS

On January 17, 2022, a landslide occurred in the Somerset neighborhood, knocking a home off its foundation. The City retained the Pacifica Law Group to assist the City in addressing various legal issues which arose as a result of the landslide, including the demolition of the home and the investigation into the cause of the landslide. On June 7, 2022, the Surdi family filed a lawsuit in King County Superior Court against the City, and on April 10, 2023, the Surdi family filed an amended complaint adding the Forest Ridge School of the Sacred Heart (the owner of the landslide property) as a defendant to their lawsuit. The Pacifica Law Group has been assisting the City in defending that lawsuit, responding to the claim for damages submitted by the Forest Ridge School, and prosecuting the City's lawsuit against the Forest Ridge School seeking recovery of its costs in responding to and cleaning up the properties damaged by the landslide. This contract amendment covers ongoing work related to these ongoing legal issues.

# POLICY & FISCAL IMPACTS

### **Policy Impact**

Bellevue City Code 4.28.040 provides that professional services contracts in excess of \$90,000 require Council approval.

### **Fiscal Impact**

This action obligates the City to increase the total contract amount for legal services provided by Pacifica Law Group LLP by \$500,000.

Sufficient funds exist within the 2023-2024 biennial budget to fund this contract.
