The PC Café: the Chef

Fact-finding and act as citizen advisors to the City Council.

Not a substitute for the City Council and serve at the pleasure of City Council.

Holds public hearing, creates legislative record, applies decision criteria, and recommendation to the City Council.

Understand difference between policy and Land Use Code (regulations).



The PC Café: *****

The PC does not represent the public, only elected officials represent the public.

- Review Staff
 Recommendation
 carefully;
- Deliberate on Staff Recommendation;
- Listen to and consider public testimony; and
- Allow every
 Commissioners' voice
 to be heard before
 voting.

Department Director, not PC, directs operations of Department



LUCA Gumbo: **Essential** Ingredients

LAND USE DISTRICTS (ZONING); DEVELOPMENT STANDARDS; PERMITS, PROCESSES & APPEALS; ADMINISTRATION

The PC Café: the Recipe for Success

LUCA decision criteria: LUC 20.30J.135.

The City may approve or approve with modifications a LUCA if:



- A. Consistent with the Comprehensive Plan; and
- B. Enhances the public health, safety or welfare; and
- C. LUCA is not contrary to the best interest of the citizens and property owners of the City of Bellevue.

The Essential Ingredient =

LUC 20.30J.135.A:

The LUCA is consistent with the Comprehensive Plan.

"Can't make the LUCA gumbo without the roux!"





Not too spicy!

Criteria B and C are essential ingredients in the City Council's recipe, not the Planning Commission's recipe!

Council has found, through the adoption of the Comprehensive Plan, that the Plan serves the public health, safety, welfare and best interest of the public.

"Thus, keep your eye on the roux!"

Ensure the Land Use Code Amendment is consistent with, and implements, the Comprehensive Plan.



Consistency with the Comprehensive Plan is required

GMA & CITY OF BELLEVUE

REQUIREMENT

CONSISTENCY W/COMP PLAN = COMPATIBLE WITH W/COMP PLAN



Compatibility with the Comprehensive Plan is critical

DETERMINING COMPATIBILITY

STRAWBERRIES & PEPPER

Co-exist in a stable fashion without unduly negatively impacting the plan

Not being in conflict with

Ingredients

- Draft Comprehensive Plan policies for Wilburton
- Draft Land Use Code amendments for Wilburton
- General Comprehensive Plan policies
- Environmental review, DEIS, and FEIS
- CAC recommendations as baseline
- City growth, affordable housing, equity, and sustainability
- Staff expertise
- Public comment/stakeholder input




Step 1: Combine and sift (in Study Session)

- Combine ingredients.
- Sift through DEIS, FEIS, CAC and Staff Recommendations, City Growth (sift).
- Set aside.



Example: Zoning

- Preferred land use alternative selected in summer 2023
- 2. Establish Comp Plan Land Use Designations (growth strategy) informed by FEIS findings
- Land Use Districts will be based on selected growth strategy
 - Will not be Wilburtonspecific



EIS Preferred Alternative for Wilburton

Example: Development Regulations (LUCA)

- Wilburton LUCA being drafted to carry out City priorities identified in Comprehensive Plan policies
- Structure of LUCA will take different approach than previous initiatives
 - Downtown, BelRed, East Main, etc. have their own specific standards, definitions, and processes in Chapter 20.25 LUC
 - Wilburton regulations will be housed throughout LUC
 - Intended to standardize, simplify LUC

Step 2: Whisk additional ingredients

- Hold a <u>public hearing</u> and consider oral and written public comment.
- Mix to ensure that all comments are considered.
- Combine.
- Check to ensure freshness.



Step 3: Bake

- Evaluate draft comprehensive plan policies for consistency with LUC 20.30I.150; and
- Thereafter, <u>check internal</u> <u>temperature</u> =

Wilburton LUCA Schedule

- Policies will be reviewed alongside implementing regulations
- Study sessions 2-4 will be sorted by three (3) topic areas
- Two (2) public hearings needed:
 - Policy Amendments (first)
 - Land Use Code Amendments

1	Land Use Designations & Future Land Use Map (w/ CPPU)
2	Transportation, Streets, Blocks
3	Site Organization, Buildings, Design
4	Land Use, Incentives, Housing
5	Public Hearings
Additional Meeting (if needed)	Recommendation to Council

Serve recommended Comprehensive Plan policies and Land Use Code amendments to the City Council.

For best results, serve while fresh.



The PC Café: Public Hearings

- Provides a forum to obtain public comment/input on CPA or LUCA.
- Public testimony should address the CPA or the LUCA.
- Planning Commission gathers public input prior to transmitting recommendation to the Council.



- Planning Commission role during public hearing is to listen to and consider public comment and act as fact-finder for the City Council.
- However, Planning Commission may sometimes make recommendations that are unpopular with the public, or even the City Council.

The PC Café: Walk-ins Welcome!


Public meetings are governed by the Open Public Meetings Act.

The public is often allowed to participate in public meetings, but public participation is not always required by state law.

On the other hand, when the Planning Commission schedules a public hearing, the public hearing is required by law.
