CITY COUNCIL AGENDA MEMORANDUM

SUBJECT:

Resolution No. 8902 authorizing the execution of a five-year General Services Contract with Stripe Rite Inc., in a total contract amount of \$549,120.45, to provide annual city-wide traffic striping maintenance.

FISCAL IMPACT:

Services provided under this contract will support programs approved by Council with funds appropriated in the 2015-2016 Budget. Funding for the latter years of the contract will be requested as part of the 2017-2020 Budgets.

This agreement commits the City to a five-year General Services Contract with Stripe Rite Inc. for annual city-wide traffic striping maintenance in the amount of \$109,824.09 per year, with a full value of \$549,120.45, including all applicable taxes.

POLICY CONSIDERATION:

City contracting policies:

The City contracts for services when it is cost effective, the work requires specialized equipment or expertise, or there are factors that render it impractical for City staff to perform the work. The proposed contract is consistent with that practice and with the City's contracting and purchasing policies.

BACKGROUND:

Traffic striping requires regular painting to ensure that lane markings and traffic channelization provide clear and highly visible delineation to vehicle traffic. Annual painting of traffic striping is needed to meet City and Federal standards, to reduce the probability of damages and claims, and to meet the City's customer service goals.

RFP RESULTS:

The Engineer's Estimate for this project was \$566,520.00. Two contractors submitted quotes for the city-wide Traffic Striping project as follows:

Stripe Rite Inc.	\$549,120.45
Apply A Line Inc.	\$789,913.85

The low quote for this contract by Stripe Rite Inc. is 3.1 % below the Engineer's Estimate. The quote has been evaluated by staff and is considered to be balanced, fair and competitive. The City opted to take advantage of the favorable bidding climate and advertise this project as a five-year contract.

EFFECTIVE DATE:

If adopted, this Resolution will become effective immediately.

OPTIONS:

- 1. Adopt the Resolution authorizing the execution of a five-year General Services Contract with Stripe Rite Inc., in a total contract amount of \$549,120.45, to provide annual city-wide traffic striping maintenance.
