AN ORDINANCE repealing Appendix A to Ordinance No. 4526, as subsequently amended, (Bellevue City Code Section 3.80 Whistleblower Policy and Procedure) and replacing it with a new Appendix A to Bellevue City Code Section 3.80 to reflect current contact information for public agencies that enforce laws or investigate issues related to whistleblower complaints; and conferring authority on the City Manager or his designee to update Appendix A in the future as necessary or appropriate.

WHEREAS, Ordinance No. 4526's Appendix A contains contact information for public agencies that enforce laws or investigate issues related to whistleblower complaints; and

WHEREAS, Appendix A has not been updated for 22 years and needs updating; and

WHEREAS, no other provisions of BCC 3.80 are affected by this Ordinance; now therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Appendix A to Ordinance No. 4526, as subsequently amended, (Bellevue City Code 3.80 Whistleblower Policy and Procedure) is hereby repealed.

Section 2. A new Appendix A to Bellevue City Code Section 3.80 reflecting the current contact information for public agencies that enforce laws or investigate issues related to whistleblower complaints is hereby adopted (attached).

Section 3. The City Manager or his designee is authorized to update Appendix A in the future as necessary or appropriate.

Section 4. This Ordinance shall take effect and be in force five (5) days after its passage and legal publication.
