## **ORDINANCE NO. 6267**

AN ORDINANCE amending Ordinance 6104 to extend the existing boundaries of Residential Permit Parking Zone 2 to include NE 25th Street, between 162<sup>nd</sup> Avenue NE and 164<sup>th</sup> Avenue NE, restricting parking on the street to "No Parking 7am to 4pm, Except Saturday, Sunday, and Holiday, Except by Zone 2 Permit."

WHEREAS, Policy TR-119 of the Transportation Element of the Comprehensive Plan states that the City will minimize spillover parking from commercial areas, parks, and other facilities encroaching on residential neighborhoods through residential parking zones; and

WHEREAS, over the past 25 years, the Transportation Department has worked with residents living near Interlake High School to address student parking through the implementation of Residential Permit Parking Zone (RPZ) 2; and

WHEREAS, in 2011 the City Council passed Ordinance 6026 to clarify the limits of RPZ 2; and

WHEREAS, following the passage of Ordinance 6026, spillover parking relocated east of the school; and

WHEREAS, in 2013 the City Council passed Ordinance 6104, amending Ordinance 6026, to extend the existing boundaries of RPZ 2 to include 165<sup>th</sup> Place NE, between NE 21<sup>st</sup> Place and NE 19<sup>th</sup> Place; and

WHEREAS, since the passage of Ordinance 6104, spillover parking has relocated north of the school; and

WHEREAS, due to the student population increase at Interlake High School and relocation of spill over parking, Ordinance 6104 must be amended to expand RPZ 2 to the north of the school; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 1 of Ordinance 6104 is hereby amended as follows:

A new Residential Permit Parking Zone 2 is hereby created for NE 21st Place between 164th Avenue NE and 165th Place NE, 162nd Avenue NE between NE 24th Street and NE 26th Street, 160th Avenue NE between Northup Way and NE 19th Place, NE 19th Place between 160th Avenue NE and 161st Avenue NE, and 161st Avenue NE between Northup Way and NE 19th Place, and 165th Place NE, between NE 21st Place and NE 19th Place, and <u>NE 25th Street, between 162nd</u> <u>Avenue NE and 164th Avenue NE, restricting parking on the street to "No Parking</u> <u>7am to 4pm, Except Saturday, Sunday, and Holiday, Except by Zone 2 Permit."</u>

Section 2. This Ordinance shall take effect and be in force thirty (30) days after its passage and legal publication.
