ORDINANCE NO. 6294

AN ORDINANCE 1) authorizing execution of an Interlocal Agreement (and supplements if necessary) with King County Metro (KCM) for acceptance of \$275,000 in pass-through grant funds from KCM for the Citywide Transportation Demand Management (TDM) Implementation Project 2015-2018; 2) amending the 2015-2016 Operating Grants, Donations and Special Reserves Fund by increasing the appropriation by \$275,000; and 3) authorizing an amendment to the existing professional services contract (and supplements if necessary) with the Bellevue Downtown Association (BDA) to add \$65,000 for trip reduction services associated with implementing the TDM Implementation Project 2015-2018.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute an Interlocal Agreement (and supplements if necessary) with King County Metro (KCM) for acceptance of \$275,000 in pass-through grant funds from KCM for the Citywide Transportation Demand Management (TDM) Implementation Project 2015-2018, a copy of which Interlocal Agreement has been given Clerk's Receiving No.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said Interlocal Agreement.

Section 3. At the time of execution of said Interlocal Agreement and acceptance of said funds, a project shall be established within the Operating Grants, Donations and Special Reserves Fund into which all said respective grant monies shall be deposited.

Section 4. The City Manager or his designee shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements regarding the use thereof to expend funds as provided in the Interlocal Agreement.

Section 5. The approximate amount and anticipated source of revenue for said grant monies are:

1-90 Manage Demand Regional Mobility Grant \$225,000 CMAQ Community Trip Reduction Initiative Grant \$50,000 Total Grant Funds \$275,000

Section 6. Upon execution of said Interlocal Agreement, the budget for the 2015-2016 Operating Grants, Donations and Special Reserves Fund shall be amended by appropriating \$275,000 to said fund.

Provided, however, if the actual revenue received from the anticipated sources specified in said Interlocal Agreement shall be more or less than the anticipated amount set forth herein, the appropriations shall be adjusted to equal the amount actually received.
