

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6307

AN ORDINANCE authorizing execution of a contract to accept reimbursement grant funds from the King County Flood District to reduce flooding through channel and culvert improvements in the upper Kelsey Creek basin near Larsen Lake and authorizing expenditures of said grant funds.

WHEREAS, the King County Flood District's Board of Supervisors passed Resolutions FCD2013-14.3 and FCD2014-14-3 which established a Flood Reduction Grant Program, criteria, and appropriated \$2,883,634 to fund flood reduction projects; and

WHEREAS, in September 2015, Bellevue was selected to receive \$94,540 from the Flood Reduction Grant Program; and

WHEREAS, the \$94,540 will be used for the upper Kelsey channel project, which was identified in the FY 2015-2021 Capital Investment Program adopted by Council in 2014 under D-94, project 10 "Phantom/Larson Lake Channel Regrade to reduce flooding in the area of Kelsey Creek upstream of Larsen Lake and below the intersection of SE 16th and east of 156th; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES
ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute a contract to accept reimbursement grant funds from the King County Flood District to reduce flooding through channel and culvert improvements in the upper Kelsey Creek basin near Larsen Lake and authorizing expenditures of said grant funds, a copy of which contract shall be substantially in the form given Clerk's Receiving No. _____.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said contract.

Section 3. The City Manager or his designee shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements regarding the use thereof including consultant agreements to expend funds as provided in said grant agreement.

Section 4. The approximate amount and anticipated source of revenue for the grant proposal and acceptance is:

King County Flood District \$94,540

Section 5. Upon execution of said contract, the budget for the Utilities D-94, Flood Control Capital Program shall be amended by appropriating revenues in the amount of the grant and acceptance herein authorized.

Provided, however, if the actual revenue received from the anticipated source specified in said contract should be more or less than the anticipated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received.

Section 6. This Ordinance shall take effect and be in force five (5) days after its passage and legal publication.
