EXECUTIVE SUMMARY

This agreement will provide overall quality assurance materials testing and inspection services for Transportation City and levy funded projects.

BACKGROUND/ANALYSIS

The Transportation Department uses contracts to supplement City forces providing quality assurance materials testing and inspection services on CIP projects. The City issued a Request for Qualifications (RFQ) with the required language to provide these services over the next four years. The contract will allow Otto Rosenau & Associates, Inc. to provide overall quality assurance materials testing and inspection services in accordance with WSDOT LAG Manual, project contract documents, and WSDOT and AASHTO Specifications.

The below CIP projects will require Quality Assurance Materials Testing and Special Inspection Services during this timeframe:

The City's Procurement Services Division is coordinating the effort to competitively solicit and award contracts that meet federal standards for reimbursement and funding.

An RFQ was issued in March 2018 for Quality Assurance Materials Testing and Inspection Services which includes on-site testing and inspection of construction materials; non-destructive examination and testing of concrete, welding, structural steel and other construction materials/structures; sampling and testing of mineral aggregates for acceptance; and project construction materials documentation and certification services. Five submittals were received. A selection committee of five City staff from various departments reviewed, evaluated, and scored the submittals based on the criteria in the RFQ. City staff recommended award to the two highest-ranked Consultants.

POLICY & FISCAL IMPACTS

Policy Impacts:

Bellevue City Code 4.28.030(B) (1)

The City has promulgated policies, standards, and operational procedures that support open, fair, and transparent procurement of goods and services in accordance with all applicable laws. Such policies, standards and procedures may define the levels of authority pertaining to review and approval of contract change orders and shall be followed by all City departments.

Fiscal Impacts:

This action will obligate the City to a maximum of \$500,000, plus all applicable taxes, with Otto Rosenau & Associates, Inc., to provide quality assurance materials testing and inspection services for Transportation City and levy funded projects. The contract is for a four-year term with an option to extend the contract for an additional year and \$125,000, plus all applicable taxes, with the same terms and conditions. Sufficient funds exist in the 2017-2023 Capital Investment Program (CIP) through the individual Transportation CIP project budgets to fund these services. Funding for future years will be contingent upon approved capital funds.
