

CITY OF BELLEVUE, WASHINGTON

RESOLUTION NO. 9488

A RESOLUTION authorizing the execution of documents necessary to release a portion of one existing electrical service easement and the entirety of a second electrical service easement, located at 905 Shoreland Drive SE that have been declared surplus to the City's needs and are no longer required for providing continued public utility service; the granting and recording of such releases being deemed in the best interest of the public.

WHEREAS, RCW 35.94.040 and Bellevue City Code (BCC) 4.32.070 provide that whenever a city determines by resolution of its legislative authority, that any lands, property, or equipment originally acquired for public utility purposes is surplus to the city's needs and is not required for providing continued public utility service, then such legislative authority by resolution and after a public hearing may cause such lands, property, or equipment to be leased, sold, or conveyed; and

WHEREAS, pursuant to BCC 4.32.070, such resolution shall state the fair market value and such other terms and conditions for such disposition as the Council deems to be in the best public interest; and

WHEREAS, the fair market value of said easements are estimated to be \$32,000; and

WHEREAS, a replacement easement will be conveyed to the City which provides a public benefit equivalent to or better than the original easements; and

WHEREAS, on September 17, 2018, by Resolution No. 9467, Council declared a portion of one existing electrical service easement and the entirety of a second electrical service easement, (as depicted on Attachment A) as surplus to the City's needs and no longer required for providing continued public utility service; and

WHEREAS, Council held a public hearing on November 5, 2018, as the required prerequisite to authorizing relinquishment of the utility easements; and

WHEREAS, Council finds that the relinquishment of a portion of the electrical service easement bearing King County Recording Number 20031204002538 and the entirety of the electrical service easement bearing King County Recording Number 20030825002910, both located on the property at 905 Shoreland Drive SE in Bellevue, Washington, is deemed in the best interest of the public; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES
RESOLVE AS FOLLOWS:

Section 1. The City Manager or his designee is hereby authorized to execute documents necessary to relinquish a portion the electrical service easement bearing King County Recording Number 20031204002538 and the entirety of the electrical service easement bearing King County Recording Number 20030825002910, both located on the property at 905 Shoreland Drive SE in Bellevue, Washington (as depicted on Attachment A).
