EXECUTIVE SUMMARY

This Resolution authorizes execution of a General Services contract for landscape maintenance services with Signature Landscape.

RECOMMENDATION

Move to adopt Resolution No. 9497.

BACKGROUND/ANALYSIS

Parks utilizes landscape contractors to perform maintenance services at parks and facilities throughout the City of Bellevue. This contract will be for services at Crossroads South Parking Lot, Chesterfield Beach Park, SE 40th Boat Launch, Tam O'Shanter Park, Bellevue Aquatic Center, and Ivanhoe Park. Landscape maintenance contracts include mowing, shrub pruning, weed control, hard surface cleaning, irrigation system operation, leaf removal, and garbage disposal.

POLICY & FISCAL IMPACTS**Policy Impact**Bellevue City Code

BCC 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required to award the bid where the cost exceeds \$90,000. This bid reflects the lowest, responsible cost proposal following a competitive process utilizing the current state-mandated prevailing wages established by the Washington Department of Labor and Industries.

Comprehensive Plan, Parks, Recreation & Open Space Element:

PA-29. Design, construct, operate, and maintain parklands and facilities to preserve the ecology of natural systems on parklands.

Fiscal Impact

This action will obligate the City to an amount up to \$191,139.86, plus all applicable taxes for execution of a new General Services contract serving four park sites and City facilities, commencing January 1, 2019 and concluding December 31, 2020.

If approved, the City will execute this contract for an initial two-year period. Upon satisfactory performance, the City will have the option to renew the contract for an additional two years for an amount up to the original contract value plus any State-mandated prevailing wage increase and/or City-approved special or unanticipated market condition that does not exceed the Consumer Price Index (CPI-U, Seattle-Tacoma-Bellevue) for the most recently completed calendar year.

This expenditure was anticipated in the 2019-2020 proposed budget. Additional funding for the renewal option will be requested in a subsequent budget process.

OPTIONS

1. Adopt the Resolution authorizing execution of a General Services contract with Signature Landscape. The contract is for an initial two-year term in an amount not to exceed \$191,139.86, plus all applicable taxes. This includes \$15,500.00 in contingency funds with an option to renew for an additional two years in an amount not to exceed \$191,139.86 plus any State-mandated prevailing wage increase and/or City-approved special or unanticipated market condition that does not exceed the Consumer Price Index (CPI-U, Seattle-Tacoma-Bellevue) for the most recently completed calendar year.
2. Do not adopt the Resolution and provide alternative direction to staff.
