Pursuant to the procedures promulgated by the City Council, I write to provide this letter of interest in applying for the Position 5 seat recently vacated by Councilmember Slatter. I will address the three questions posed by the Council and then provide some closing comments.

Question One: What is your passion for the community?

I hope this finds each of you and yours well! Before I share with you my passion for our community, my vision for our City and my desire to serve with you, I'd like to thank you each for your own long-standing service. As you all know, it is a privilege to serve, but the privilege is earned through selflessness and sacrifice of time, talent and treasure and upholding one's commitments. Thank you for doing just that.

What is your passion for the community?

My passion is to continue to build upon and to enhance the already excellent quality of life experienced by Bellevue residents. When my family moved here twenty years ago it was obvious the desirability of the area would continue to attract people and businesses that prioritize this high quality of life as a reason to locate in Bellevue. With success also comes challenges; three areas that I have focused on improving are transportation, education and the arts. As evidence of my commitment, I have served as board chair for the Bellevue Transportation Commission, Bellevue Christian School and the Bellevue Youth Symphony Orchestra. Recently I was appointed to Sound Transit's Citizen Oversight Panel and look forward to contributing to this regional agency's critically important role both in both Bellevue and the broader region.

The other area I am passionate about is affordable housing. Given the unique geography of the area and well-intentioned but further constraining restrictions due to the Growth Management Act, affordability has become more critical to address. This limited affordability has a direct link to transportation as employees are required to move farther away from job centers. With virtually no new areas available for development of traditional single family housing, more innovative strategies and solutions will be necessary such as increased transit oriented development and partnerships such as occurred with Highland Village between the city and the King County Housing Authority. I believe providing affordable, high-quality housing will continue to be an extremely challenging issue for Bellevue and the region.

What is your vision for the city?

Bellevue should continue on its current trajectory of becoming a world-class city while maintaining the outstanding quality of life for its residents. This is accomplished through effective planning, both near term as well as longer term for future generations.

Two near term areas of importance that are being addressed are the development of a vibrant waterfront and enhanced cultural opportunities, the former being initiated through the Meydenbauer Bay Park plan and the latter by the Tateuchi Center project.

Longer term, the well-planned additional build out of the downtown area, guided by the Downtown Livability Initiative, as well as the landmark Bel-Red redevelopment initiative, will provide the necessary commercial capacity and, to a lesser extent, residential capacity to achieve the world class city vision. There will be challenges in providing adequate infrastructure, particularly in the areas of transportation and housing, in realizing this vision. Cooperation and partnerships with other Eastside cities as well as other state and regional agencies will be of critical importance. While transit planning is progressing well with East Link and the Bellevue Transit Master Plan, ongoing coordination with both Sound Transit and WSDOT for a robust BRT network and completion of the I-405 Master Plan are necessary to provide internal and external mobility for those living and/or working in Bellevue.

Further, the cultural diversity of Bellevue is a tremendous asset that fosters the environment necessary for achieving world-class status for the city and this attribute should continue to be emphasized as an integral part of the vision. The fact that the Global Innovation Exchange chose Bel-Red for its campus was a landmark step that validates both the city's planning effort as well as its competitiveness globally.

In summary, my vision for Bellevue is to be a city that welcomes the world and is a thriving center for commerce and entertainment, a leader in innovation and a model for growth.

Why do you want to serve on the Bellevue City Council?

I am extremely proud to be a resident of Bellevue and grateful for the opportunity to raise my family in such a wonderful place. As evidenced by my prior service, I am fortunate to have the time and resources to be able to contribute to the causes I am passionate about. To Those Responsible for the Decision Making regarding the Open Bellevue City Council Position Number 5;

This is my Letter of Serious Interest in Bellevue's City Council.

What is your passion for the community?

For nearly thirty years, I have enjoyed living with my family in Bellevue. I didn't, however, fully appreciate what went into the creation of this award-winning city.

My perspective changed in 2013 when I collaborated with the City to bring about an ordinance that would ban individual room rentals in single family neighborhoods. This practice had sprung up in my neighborhood and throughout the City. While highly profitable for the business enterprise, it violated the spirit of the land use code for single family neighborhoods. The practice had reduced the number of affordable homes in single family neighborhoods at a time when more affordable homes were needed.

To remedy this, I led a group of civic-minded neighbors to persuade City Council to develop an ordinance that would protect quality of life in single-family neighborhoods in Bellevue. During my investigation, I discovered that student housing was needed in the area surrounding Bellevue College and that future institutions of higher education would have the same need. The issue of student housing and the policies relating to it were incorporated into the Comprehensive Plan as a result of this effort. The new room rental ordinance has also been used to prevent the use of Air B&B and VRBO (Vacation Rental by Owner) in single family neighborhoods, again helping prevent upward pressure on housing costs in single family neighborhoods.

This firsthand experience in what it takes to make a change to Bellevue policies and laws has given me inspiration to do more to help Bellevue continue to be a world-class city.

As a member and current Vice Chair of the Planning Commission, I have been involved in the following activities that have prepared me for a position on the City Council...

- Updating the 2015 Comprehensive Plan
- Downtown Livability Analysis and Discussion
- Eastgate I-90 Transportation Master Planning

- Low Impact Development Principles
- Marijuana Land Use Recommendations
- Comprehensive Plan Amendments
- Land Use Review and Code Updates
- Public Hearings

My involvement in issues that impact the quality of life in the city I love has inspired me to want to be of more service to Bellevue.

What is your vision for the City?

My vision for Bellevue is one of growing inclusion - where every resident feels significant and every visitor is welcome. Bellevue embraces the varied and diverse values, backgrounds, interests, and capabilities of all its residents. A feeling of safety and security is fostered through robust emergency services, social services, infrastructure and neighborhood activities.

Bellevue residents are engaged in regional issues impacting Bellevue. Leveraging the brain trust that is held in the Bellevue resident leads to significant outcomes.

Every resident and neighborhood has parity when seeking a high quality of life for themselves, their families and their community.
