POLICY CONSIDERATION

Should the City continue to retain outside counsel to assist in the defense of this lawsuit?

BACKGROUND

Eddie Williams filed a lawsuit against the City of Bellevue and Police Chief Stephen Mylett in July 2016 alleging violations of state and federal law. Mr. Williams claims that he was subject to race discrimination and unlawful harassment while he worked for the Bellevue Police Department and that he was retaliated against for reporting this conduct. The City retained Keating, Bucklin & McCormack, Inc., P.S. to assist the City in the defense of the City and Chief Mylett. This lawsuit is scheduled to go to trial on November 6. An amendment to the Professional Services Agreement is necessary to provide sufficient funding for the City to complete discovery, prepare and file motions, and prepare for and attend trial.

EFFECTIVE DATE

If approved, this Resolution becomes effective immediately upon Council adoption.
