## CITY OF BELLEVUE, WASHINGTON

## ORDINANCE NO. 6360

AN ORDINANCE authorizing acceptance of 2016 Assistance to Firefighters Grant funds from the Department of Homeland Security (DHS), Federal Emergency Management (FEMA), of up to \$92,861 to establish a formal Fitness and Injury Prevention Program for uniformed fire personnel; establishing a project within the Operating Grants, Donations and Special Reserve Fund; amending the 2017-2018 Operating Grants, Donations and Special Reserves Fund by increasing the appropriation by up to \$92,861; appropriating revenues to that fund; and authorizing expenditures of said grant funds.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to accept the 2016 Assistance to Firefighter Grant from DHS, FEMA, of up to \$92,861 to establish a formal Fitness and Injury Prevention Program for uniformed fire personnel, a copy of which Grant Agreement Articles is given Clerk's Receiving No. \_\_\_\_\_.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said Grant Agreement Articles.

Section 3. At the time of acceptance of said Grant Award and funds, a project shall be established within the Operating Grants, Donations and Special Reserve Fund into which all said monies shall be deposited.

Section 4. The City Manager or his designee shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements regarding the use thereof including purchase agreements to expend funds as provided in Grant Award.

Section 5. The approximate amount and anticipated source of revenue for the grant proposal and acceptance is:

Department of Homeland Security (DHS), FEMA \$92,861

Section 6. Upon acceptance of said Grant Award, the budget for the 2017-2018 Operating Grants, Donations and Special Reserve Fund shall be amended by 1594-ORD 12/26/18

appropriating revenues in the amount of the grant and acceptance herein authorized.

Provided, however, if the actual revenue received from the anticipated source specified in said Grant Award should be more or less than the anticipated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received.
