

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6361

AN ORDINANCE 1) authorizing execution of a grant agreement (and supplements if necessary) with the Washington State Department of Transportation (WSDOT) for acceptance of \$778,559 in federal Safe Routes to School Program funding for the Sherwood Forest Elementary School and Interlake High School Non-Motorized Safety Improvements Project; 2) amending the 2017-2018 General Capital Investment Program (CIP) Fund to increase the appropriation by \$778,559; and, 3) amending the 2017-2023 CIP Plan to increase the budget for the Minor Capital – Traffic Operations program (CIP Plan No. PW-M-2) by \$778,559.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute a grant agreement (and supplements if necessary) with WSDOT for acceptance of \$778,559 in federal Safe Routes to School Program funding for the Sherwood Forest Elementary School and Interlake High School Non-Motorized Safety Improvements Project, a copy of which grant agreement shall be substantially in the form given Clerk's Receiving No. _____.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said grant agreement.

Section 3. The City Manager or his designee shall have responsibility for the administration of said funds and expenditure of said funds received pursuant to said grant agreement and shall have all authority necessary to enter into agreements regarding the use thereof.

Section 4. The 2017-2018 General Capital Investment Program (CIP) Fund, adopted by Ordinance No. 6333 on December 5, 2016, as previously amended, is hereby further amended to increase the appropriation to said CIP Fund by \$778,559.

Section 5. The City's 2017-2023 CIP Plan, adopted by Ordinance No. 6333 on December 5, 2016, is hereby amended to increase the project budget for the Minor Capital – Traffic Operations program (CIP Plan No. PW-M-2) by \$778,559 awarded from the federal Safe Routes to School Program funding.

Section 6. If the actual revenue received from WSDOT Safe Routes to School Program funding shall be more or less than the anticipated amount set forth herein, the appropriations to the CIP Fund and Plan shall be adjusted to be equal to the amount actually received.

Section 7. This Ordinance shall take effect and be in force five (5) days after its passage and legal publication.
