

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6357

AN ORDINANCE related to a residential parking zone; repealing Ordinance Nos. 6026, 6104, and 6267; establishing Residential Permit Parking Zone 2; and delegating authority to the City Manager or designee to establish time-limited parking or time of day restrictions for vehicles without a Zone 2 permit on an as needed basis on various streets surrounding Interlake High School.

WHEREAS, Policy TR-149 of the Transportation Element of the Comprehensive Plan states that the City will minimize spillover parking into residential neighborhoods through residential parking zones and other measures; and

WHEREAS, over the past 25 years, the Transportation Department has worked with residents living near Interlake High School to address student parking through the implementation of Residential Permit Parking Zone (RPZ) 2; and

WHEREAS, in 2011 the City Council passed Ordinance 6026 to clarify the limits of Zone 2; and

WHEREAS, following the passage of Ordinance 6026, spillover parking relocated east of the school; and

WHEREAS, in 2013 the City Council passed Ordinance 6104, amending Ordinance 6026, to extend the existing boundaries of Zone 2 to include 165<sup>th</sup> Place NE, between NE 21<sup>st</sup> Place and NE 19<sup>th</sup> Place; and

WHEREAS, since the passage of Ordinance 6104, spillover parking relocated north of the school; and

WHEREAS, in 2016 the City Council passed Ordinance 6267, amending Ordinance 6104, to extend the existing boundaries of Zone 2 to the north of the school; and

WHEREAS, since the passage of Ordinance 6267, spillover parking has relocated to 161<sup>st</sup> Avenue NE between NE 24<sup>th</sup> Street and NE 26<sup>th</sup> Street; and

WHEREAS, due to the student population increase at Interlake High School spillover parking is expected to continue; and

WHEREAS, establishing a larger Zone 2 proactively allows the city to be more responsive and expeditious in responding to spillover parking concerns when they do actually occur; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES  
ORDAIN AS FOLLOWS:

Section 1. Ordinance Nos. 6026, 6104 and 6267 are hereby repealed.

Section 2. Residential Parking Zone 2 is hereby established.

- A. The parking of vehicles on the following streets is restricted to “No Parking 7am to 4pm, Except Saturday, Sunday, and Holiday, Except by Zone 2 Permit”:

NE 21st Place between 164th Avenue NE and 165th Place NE  
162nd Avenue NE between NE 24th Street and NE 26th Street  
160th Avenue NE between Northup Way and NE 19th Place  
NE 19th Place between 160th Avenue NE and 161st Avenue NE  
161st Avenue NE between Northup Way and NE 19th Place  
165th Place NE between NE 21st Place and NE 19th Place  
NE 25th Street between 162nd Avenue NE and 164th Avenue NE  
NE 21<sup>st</sup> Street between 165<sup>th</sup> Place NE to end of cul-de-sac  
161st Avenue NE between NE 24th Street and NE 26th Street

- B. The parking of vehicles on the following streets may be restricted to certain time limits or during specified times of the day, except by Zone 2 permit, when signs are present:

162nd Avenue between Northup Way to NE 19th Place  
NE 19th Place between 162nd Avenue NE to 163rd Avenue NE  
NE 19th Street between 163rd Avenue NE to end of cul-de-sac  
163rd Avenue NE between NE 18th Street and NE 19th Place  
NE 18th Street between 162nd Avenue NE and 164th Avenue NE  
NE 24th Street between 159th Avenue NE to 169th Avenue NE  
158th Place NE between NE 25th Place to end of cul-de-sac  
NE 25th Place between 158th Place NE to 159th Avenue NE  
159th Avenue NE between NE 24th Street to NE 26th Street  
160th Avenue NE between NE 24th Street to NE 28th Street  
NE 27th Place between 160th Avenue NE to end of cul-de-sac  
162nd Avenue NE between NE 26<sup>th</sup> Street to NE 28<sup>th</sup> Street  
NE 26th Street between 159th Avenue NE to 164th Avenue NE  
NE 27th Street between 160th Avenue NE to 164th Avenue NE  
NE 28th Street between 160th Avenue NE to 168th Place NE  
164th Avenue NE between Northup Way to NE 28th Street  
NE 16th Place between 164th Avenue NE to 168th Avenue NE

164th Place NE between NE 16th Place to NE 17th Place

NE 27th Street between 165th Avenue NE to 167th Avenue NE  
NE 27th Place between 167th Avenue NE to end of cul-de-sac

Section 3. The City Manager, or designee, is hereby authorized to establish time limited parking or time of day parking restrictions on all or portions of the specific streets in Section 2.B, through the use of signs for vehicles without a Zone 2 permit. Such parking restrictions shall be filed and maintained with this Ordinance by the City Clerk in accordance with Bellevue City Code 11.23.010.
