Topic: Draft Options for responding to Council direction on Permanent Shelter Siting Reprinted from July 10, 2017 City Council Study Session Packet Materials

# **Summary of Discussion to-Date**

Specific to the permanent shelter discussion, the Planning Commission recommended that "transient lodging" uses should be reviewed and permitted through a conditional use process in the new land use districts located in Eastgate (EG-TOD, NMU, and OLB-2). In the Standard Land Use Coning Manual, the Residential Use Code includes a use subset that is defined as Hotel/Motel (Code 13), and a use subset that is defined as Transient Lodging not elsewhere coded (Code 15). Transient lodging uses are described in the SLUC Manual as including establishments like the YMCA and YWCA. Permanent shelters are classified as transient lodging uses under Code 15. To provide for greater transparency in the use charts, and to allow for variability in the permitting process between the Hotel/Motel uses included under Code 13 and the Transient Lodging Uses included under Code 15, the Planning Commission called out the Code 15 Transient Lodging use individually and required it to be reviewed and permitted as a conditional use. The Planning Commission did not change the permit requirements for Hotels and Motels, and these uses continue to be permitted outright in most land use districts where they are allowed.

# **Draft Options for Responding to Council Direction on Permanent Shelter Siting**

Council held a meeting on June 5, 2017 and directed staff to proceed with the Eastgate LUCA amendments as recommended by the Planning Commission with several modifications to accomplish the following objectives relative to the siting of permanent shelters:

- Maintain the Planning Commission's recommendation that distinguishes 'transient lodging' uses from hotels and motels, but permit them subject to approval of a Development Agreement rather than a CUP.
- Prohibit safe injections sites, and
- Identify opportunities to clarify the distinction between shelter uses and short terms stay
  uses such as bed and breakfast uses that are both defined as a type of "transient lodging"
  under separate sections of the LUC.

Staff has developed the following Draft LUC Option for Council consideration. It is intended to further clarify the distinction between shelter uses and short term stay uses (such as bed and breakfasts) that are both defined as "transient lodging" under separate sections of the LUC. This Draft LUC Option provides an alternative approach to the Planning Commission recommendation that can be reviewed at a later meeting in July to identify which approach best meets Council objectives relative to the siting of permanent shelters. The Draft LUC Option is

being provide now (as part of the July 10 Study Session Materials on the Eastgate LUCA), to provide the City Council and stakeholders the opportunity to review it prior to the Shelter Siting discussion that is anticipated to occur later in the month.

The Draft LUC Option for Council consideration includes the following elements:

- Modifications to the Services Use Chart of the LUC. This change would create a process
  path to permit "permanent emergency shelter" uses through approval of a Development
  Agreement by the City Council, and would clarify that transient lodging uses are limited
  to things like Bed and Breakfast and Rooming House uses.
- Modifications to the Residential Use Chart of the LUC: If "permanent emergency shelter" is added to the Services Use Chart, the reference to "transient lodging" use (Code 15) would be removed from the Residential Use charts of the LUC.
- Addition of Footnotes to the Services Use Chart: Footnotes would be added to the Services Use Chart to describe the Development Agreement process and to identify and prohibit Safe Injection Sites outright.

The Draft LUC Option for incorporation into the Eastgate LUCA is presented below. The relevant provisions have been highlighted for ease of reference.

(32) Permanent Emergency Shelters are permitted in these Land Use Districts only when the City Council has entered into a development agreement authorized by Chapter 36.70B RCW.

(33) Medically Supervised Injection Centers (MSIC) designed to provide a hygienic environment where individuals are able to consume illicit recreational drugs intravenously are prohibited. A MSIC includes all uses established for the above-defined purpose, irrespective of how the use is described, and may also be referred to as community health engagement locations, supervised injection sites or facilities, safe injection sites, fix rooms, or drug consumption facilities.
