RESOLUTION NO. 9364

A RESOLUTION initiating vacation of a portion of SE 20th Street adjacent to 1858 128th Avenue SE; and setting a time and place for a hearing to consider such a vacation.

WHEREAS, the City Council received a petition to initiate the vacation of a portion of City right-of-way, as set forth in Section 1 below, and desires to set a time and place for a hearing before the City Council to consider such vacation; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. A petition for a street vacation is hereby initiated, pursuant to section 14.35.030 of the Bellevue City Code ("BCC"), for the following City right-of-way:

A portion of SE 20th Street adjacent to 1858 128th Avenue SE, as more particularly described and depicted in Exhibit A.

Section 2. A public hearing shall be held upon the proposal to vacate the City right-of-way set forth in Section 1, on March 19, 2018, at 8:00 pm or as soon thereafter as the matter may be heard by the City Council, in the Council Chambers at Bellevue City Hall, 450 110th Ave NE, Bellevue, Washington.

Section 3. Notice of such hearing shall be provided and posted in the manner required by BCC 14.35.050 inviting interested persons to appear and be heard for or against the proposed vacation.

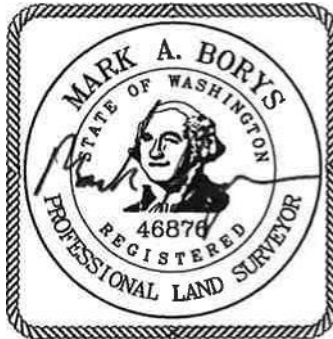
### SE 20TH ST RIGHT OF WAY VACATION

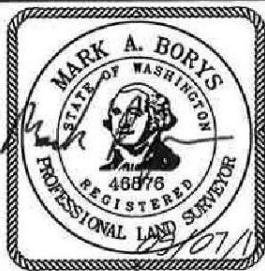
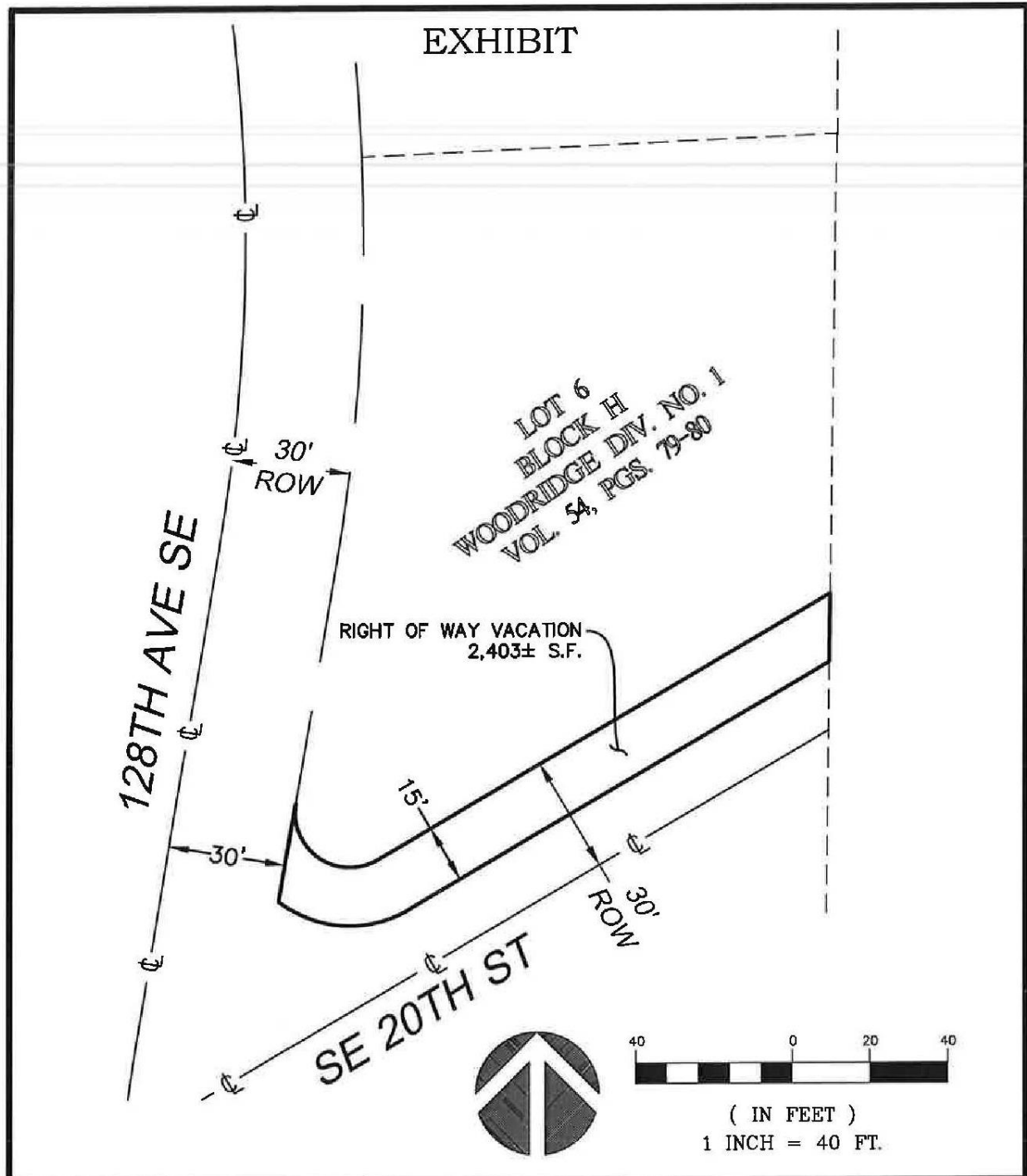
