## **EXECUTIVE SUMMARY**

This Resolution authorizes execution of a General Services contract renewal for landscape services with Canber Corp.

#### **BACKGROUND/ANALYSIS**

The Parks and Community Services Department utilizes landscape contractors to perform maintenance services at parks and facilities throughout the City of Bellevue. This contract renewal is for services at City Hall. Landscape maintenance services include mowing, shrub pruning, weed control, hard surface cleaning, irrigation system operation, leaf removal, and garbage disposal. ### **Policy Impact**

Comprehensive Plan: Parks, Recreation and Open Space Element

PA-29. Design, construct, operate, and maintain parklands and facilities to preserve the ecology of natural systems on parklands

## Bellevue City Code

BCC 4.28 provides for the fair and equitable treatment of all persons involved in the purchasing process. Council approval is required where the total contract cost exceeds \$90,000. The original contract was awarded at the lowest bidder following a competitive process utilizing the then current state-mandated prevailing wages established by the Washington Department of Labor and Industries.

The original contract was for \$33,912.16, which was subsequently reduced by \$1,584. This contract renewal in the amount of \$63,833 will bring the four-year obligation of the City to over \$90,000.

## **Fiscal Impact**

This action will obligate the City to an amount up to \$63,833, all taxes included, for execution of a General Services contract renewal serving City Hall.

Sufficient funding exists in the 2019-2020 Parks & Community Services Operating budget.
