EXECUTIVE SUMMARY

Traffic marking maintenance and repair is an important factor in safe public roadways. Meeting the designed performance measures of these systems emphasizes the City Council Vision and Priorities for Transportation and Mobility. Special equipment is required to replace large volumes of traffic control devices that are impacted from general wear from vehicle traffic volumes and snow plowing of City roadways.

BACKGROUND/ANALYSIS

This on-call contract is one of two on-call contracts that will provide for the replacement of worn or otherwise damaged or missing crosswalks, directional arrows and raised pavement markers. This contract will be used for "large" jobs where doing the work by hand is not economical. These permanent repairs are needed to meet City standards, to reduce the probability of damages and claims, and to meet the City's customer service goals.

Only one quote was received and was determined to be balanced, fair and competitive. The quote is as follows:

Stripe Rite, Inc. \$624,000

Engineers Estimate \$650,000

POLICY & FISCAL IMPACTS

Policy Impact

- TR 53: Maintain and enhance safety for all users of the roadway network.
- TR 54: Ensure that maintenance of the existing transportation system be given priority consideration.

Bellevue City Code 4.28.030(1):

- The City has promulgated procurement procedures for the utilization of on-call contracts for services and minor repair that fit within these criteria: (1) work that is not regularly scheduled but is required to maintain the asset so that further repair is not required or until larger repairs can be performed; (2) for existing infrastructure enhancements; and, (3) for projects/tasks that are simple, short-term and small in scale.
- Council approval is required for contracts greater than \$90,000.

Fiscal Impact

This action will obligate the City to a five-year on-call contract not to exceed \$624,000, plus all applicable taxes, for on-call traffic marking maintenance resulting from storm related damage and normal wear to crosswalks, lane markings and directional arrows. Sufficient funding exists in the 2019-2020 Transportation Department Operating Budget to fully fund the first two years of this contract. Additional funding associated with this contract will be requested in subsequent budgets and will be subject to final budget appropriation.

OPTIONS

- 1. Adopt the Resolution authorizing the execution of a five-year General Services Contract with Stripe Rite, Inc., in the amount of \$624,000, plus all applicable taxes, to provide on-call traffic marking maintenance.
- 2. Do not Adopt Resolution and provide alternative direction to staff.
