I find this a disturbing development. It would seem to me that a community council should hold its meetings in the community it represents. We in East Bellevue are very fortunate to have a suitable meeting place, where meetings have consistently been held for many years. This facility is easily accessible to our community.

Changing this traditional meeting place seems extremely arbitrary and counterproductive to serving East Bellevue. And changing for some of months is an additional burden to community participation, causing confusion and eventually less community interest.

Fewer residents are attending EBCC meetings. Therefore, at a time in our City when traffic is more congested than ever, when families are busier than ever, moving the EBCC meetings to downtown will be a major impediment to the already limited community participation. 



Thirty Seconds of Silence for Students

February 13, 2019 Message

"Hi Vernon Dwight, My name is Nara Kim, and I'm the executive director of March for Our Lives Seattle and a high school sophomore. Last year, youth rose up to demand action to prevent gun violence. Today, I am committed to continuing this fight. I hope you'll let me take a minute to explain why preventing gun violence is so important to me.

School shootings are something I've had to worry about for basically my entire childhood. I've been practicing active shooter drills for longer than I can remember, and I can still remember exactly where I was and what I felt when I heard about what had happened at Sandy Hook Elementary. You would expect a Gen Z kid like me to have vivid memories of getting my first phone or computer, but they're all overpowered by memories of gun violence.

I am part of the generation far too familiar with lockdowns and active shooter drills, but I'm not going to keep my mouth shut and accept that change isn't possible. I refuse to let another generation live through the horrors that my peers and I have been forced to endure."
